Introduction

Pedro De La Cruz (the "Applicant") is requesting approval of a Special Event Permit from the Mayor and the City Council to host the 2025 Miami International Taekwondo Camp Event, pursuant to Chapter 35 of the City Code of Ordinances ("City Code"). The proposed event will be hosted at Doral Legacy Park located at 11400 NW 82 Street from Saturday, August 30, 2025 to Sunday, August 31, 2025, from 9:00 a.m. to 6:00 p.m. A copy of the application is provided in "Exhibit A".

Background

The goal of this event is to promote physical fitness, discipline, and sportsmanship by providing participants with high-level training and Olympic-level mentorship. The Miami International Taekwondo Camp is honored to welcome Olympic Silver Medalist Gashim Magomedov as Head Trainer and Host.

The applicant has successfully hosted similar events in the past, including:

- 2024 Miami International Training Camp, which drew approximately 140 attendees
- 2023 Miami International Training Camp

- 5. Attendance Estimate

- The applicant estimates approximately 200 attendees will participate over the course of the event.
