



## **CITY OF DORAL COUNCIL MEETING MEMORANDUM MAYOR AND COUNCIL**

### **ITEM TITLE:**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE RESTRUCTURING OF PARKS & POLICE 4 KIDS, INC. (PP4K); PROVIDING FOR THE RECONSTITUTION OF THE BOARD OF DIRECTORS, REVISION OF THE FOUNDATION'S BYLAWS, AND REALIGNMENT OF THE FOUNDATION'S PURPOSE AND MISSION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

### **BRIEF HISTORY:**

Parks & Police 4 Kids, Inc. (PP4K) is a City of Doral affiliated 501(c)(3) nonprofit foundation established to support youth-focused initiatives that foster positive development, mentorship, and educational opportunities through programs associated with the City's Parks and Police departments. Since its creation, the foundation has served as a mechanism to enhance youth programming and community engagement beyond traditional municipal operations.

Over time, the scope and scale of youth services provided by the City of Doral have expanded significantly, with many programs currently subsidized through the City's General Fund. In order to ensure long-term sustainability, fiscal responsibility, and alignment with the City's evolving priorities, it is necessary to restructure PP4K to assume a more defined and strategic role in supporting subsidized youth programming.

The proposed restructuring includes the removal of the current board, the temporary appointment of the Mayor and City Council as the governing board for purposes of reorganization, and the comprehensive revision of the foundation's bylaws. These updates will establish a clarified mission, purpose, and governance structure, positioning PP4K to responsibly administer and support youth programs that are presently funded through the City's General Fund, while maintaining transparency, accountability, and consistency with municipal objectives.

This action will allow the City to strengthen oversight, modernize the foundation's governance framework, and ensure that PP4K operates as an effective partner in delivering impactful youth services to the Doral community.
