# Executive Project Summary

Program / Project Narrative	In its 10th year, Miami Dynasty Basketball is a nonprofit 501c3 youth basketball program affiliated with the Amateur Athletic Union of the U.S. Inc. (AAU). The program is home-based at Divine Savior Academy in Doral, Florida. The purpose of the Academy is to offer basketball training through volunteers and professional coaches, and help develop Doral kids ages 5-18 years old for recreational and competitive leagues.
Why is the program needed in Doral?	The organization grew out of demand from Doral children to train and participate in more advanced competitive/travel indoor basketball leagues. After just one year, 96 boys and girls ages 5-17 participated in Dynasty (90% are Doral residents and/or attend Doral schools). As of March of this year, we have 175 children registered.
How will the success of the program be measured?	By supporting 10 children allow them to train, compete and develop in Dynasty programs, the organization will help develop children in the sport and keep them off the streets. Dynasty will take assistance at all practices and games to ensure full participation. Dynasty will assess their athletic performance and development at the beginning and end of the program.

Total CBO Grant amount requested	Dynasty already self-funds 29 economically-disadvantaged Doral children by subsidizing their costs. This specific program to fund 10 children is estimated to cost \$16,080 for which Dynasty is requesting a grant of \$5,000.


