

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ACCESS NASPO VALUEPOINT DATA NVP No. AR3227 PARTICIPATING ADDENDUM FOR FL No. 43220000-NASPO-19-ACS CONTRACT, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, FOR THE PURCHASE OF A NETWORK AUTOMATION AND ANALYTICS PLATFORM THROUGH A FIVE (5) YEAR ENTERPRISE AGREEMENT WITH R2 UNIFIED TECHNOLOGIES; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Our current network environment relies heavily on manual configurations and reactive troubleshooting, which introduces operational risks and limits our ability to scale. As user demands and technology requirements increase, we must transition to a more intelligent, automated, and secure network architecture; and

**WHEREAS**, this platform will provide:

- Automation of network configurations and policy enforcement,
- AI-driven analytics for real-time visibility and proactive issue detection,
- Integrated security features such as segmentation and automated threat response,
- Centralized policy management to align network behavior with organizational goals,
- Scalability to support cloud, remote work, and future infrastructure needs; and

**WHEREAS**, notably, Section 119.0725 (b), Florida Statutes, creates a public records exemption related to cybersecurity. Specifically, the statute makes any information related to critical infrastructure such as this confidential and exempt from public record requirements. In addition to the public records exemption, any portion of a meeting that might reveal such information is exempt from public meeting requirements.

See Section 119.0725(3), Florida Statutes; and

**WHEREAS**, Section 2-322 of the City Code of Ordinances provides that the Council may enter into contracts procured by other public entities and cooperative purchasing ventures. Accordingly, the City may solicit the goods and services provided by vendors participating in Valuepoint Data NVP # AR3227 Participating Addendum for FL # 43220000-NASPO-19-ACS Contract.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Manager's Office respectfully requests that the Mayor and City Council Members authorize access of Valuepoint Data NVP # AR3227 Participating Addendum for FL # 43220000-NASPO-19-ACS Contract to purchase a Network Automation and Analytics Platform in an amount of Five Hundred Ninety Five Thousand, Eight Hundred Ninety One Dollars and 89/100 (\$595,891.89).

**Section 3. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution. The City Manager is authorized to expend budgeted funds. Budgeted funds for this expense are allocated in the IT Capital Account # 001.22005.500652.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
