A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER WITH EXP US SERVICES, INC. FOR THE CONSTRUCTION, ENGINEERING. & INSPECTION (CEI) AND **PROJECT** MANAGEMENT SERVICES OF ITB 2025-05 "STORMWATER IMPROVEMENTS AT SUB-BASIN D-3-1" IN AN AMOUNT NOT TO EXCEED ONE HUNDRED SIXTY-TWO THOUSAND, EIGHT AND HUNDRED FIFTY-SEVEN DOLLARS THREE CENTS (\$162,857.03); AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS: PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on August 2022 the City of Doral assigned 300 Engineering Group, P.A (300) to design stormwater improvements at Sub Basin D-3-1 which is located along NW 82nd Avenue and NW 79th Avenue between NW 25th Street and NW 29th Street, and along NW 29th Street between NW 82nd Avenue and NW 79th Avenue; and

WHEREAS, the design was completed in July 2024; and

WHEREAS, the Public Works Department (PWD) requested a proposal from EXP US Services, Inc. (EXP), a prequalified firm from the established "Pre-Qualified Pool of Consultant", for Construction, Engineering, & Inspection (CEI) and Project Management professional services for the construction of stormwater improvements at Sub Basin D-3-1, advertised as ITB 2025-05; and

WHEREAS, the award recommendation of ITB 2025-05 is also being presented at the August 2025 Council Meeting; and

WHEREAS, the PWD staff and EXP negotiated the attached proposal at a not exceeding amount of \$162,857.03; and

WHEREAS, the contract between EXP and the City of Doral was procured through the publicly advertised Request for Qualification (RFQ) 2023-08 process to select a pool of pre-qualified Engineering and Architecture firms. This group of eleven (11) firms was approved by the City Council during the March 2024 Council meeting via Resolution No. 24-54 (approved 5-0); and

WHEREAS, City staff respectfully requests that the Mayor and the City Councilmembers approve WO#2 to EXP, a copy of which is attached hereto as Exhibit "A", in an amount not to exceed \$162,857.03; and

WHEREAS, funding for this request is available in the Public Works Department Stormwater Fund, Account Num. 401.80005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The City Council hereby approves WO#2 to EXP, a copy of which is attached hereto as Exhibit "A", in an amount not to exceed \$162,857.03, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney.

Section 3. Authorization. The City Manager is authorized to execute WO#2 to EXP and expend budgeted funds on behalf of the City.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
