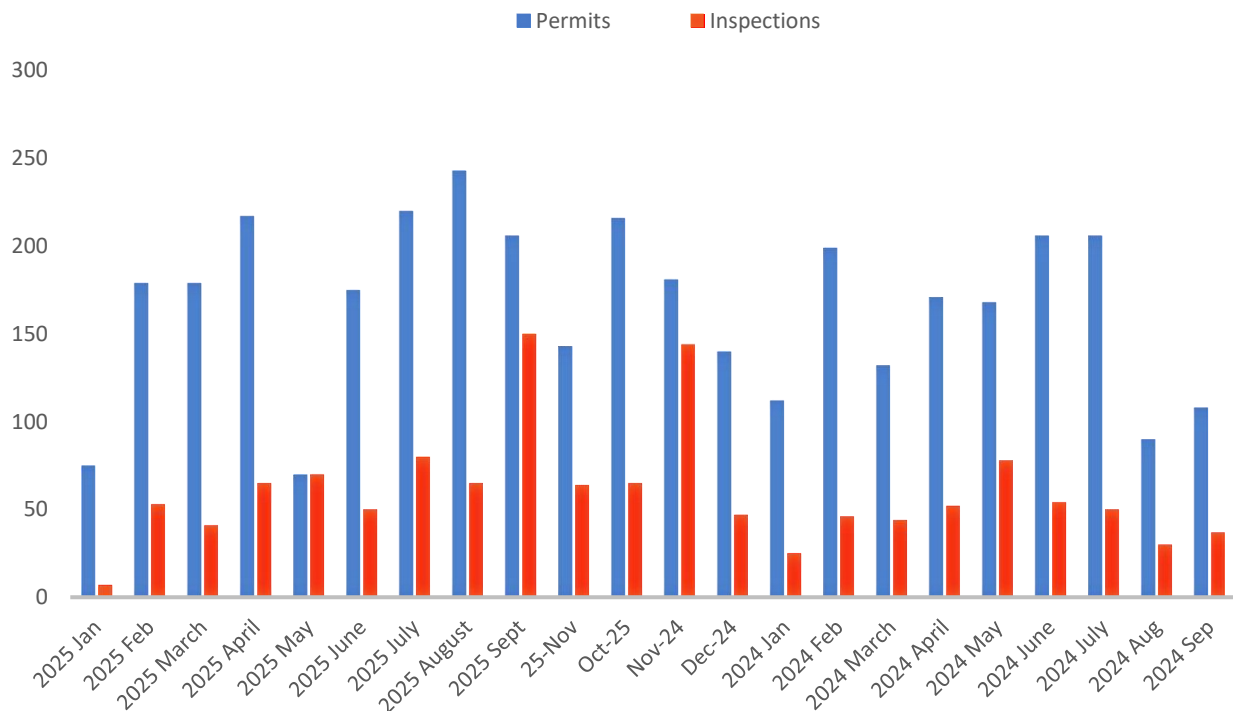

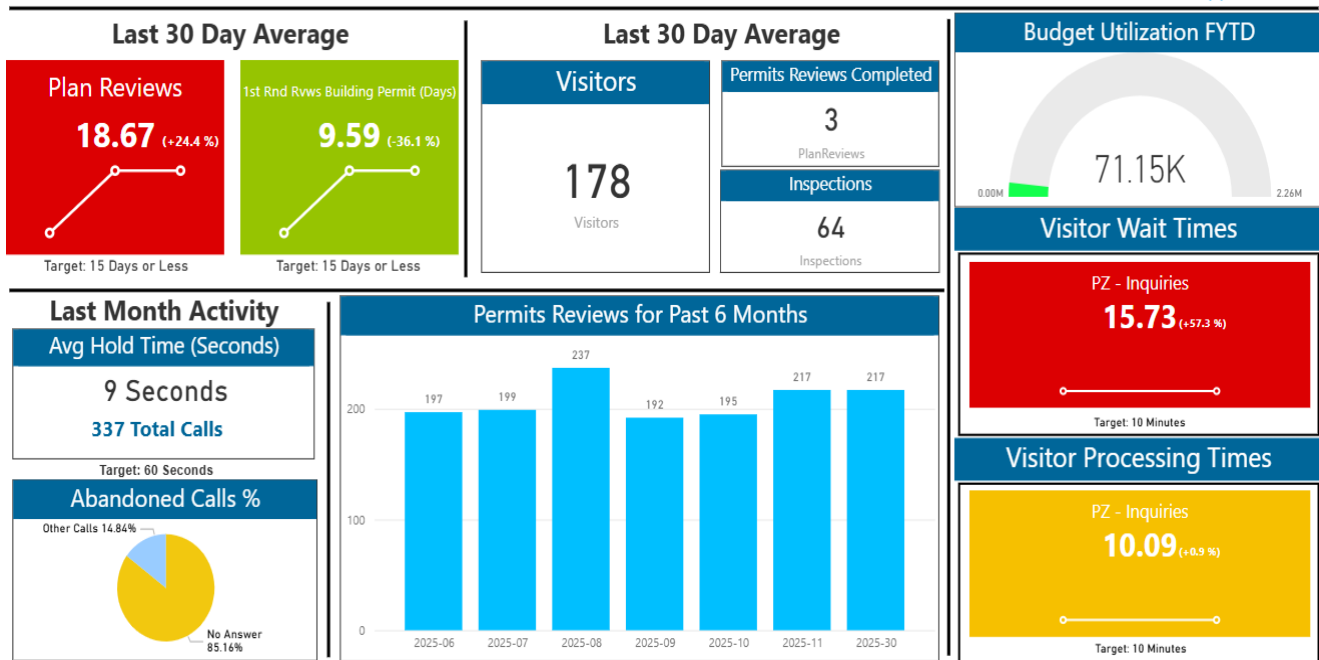

Major Project Updates

During November 12, 2025, City Council meeting, the following item was approved:

- Special Event Path to Cure (Res. No. 25-267)

Licensing Division

- 32 Business Tax Receipt applications for new license" *
- 54 Business Tax Receipt applications for new business" **
- 409 Business Tax Renewals for fiscal year 2026 during the month of October.
- 6,505 Active Business Tax Receipts for fiscal year 2026
- 57 Certificate of Use issued during the month of October.
- 3 State alcohol packets were reviewed for compliance with the City Code.
- 1 Outdoor Dining packet was reviewed for compliance with City Code.

As of November 30, 2025, there were 6,505 active businesses. The renewal process began June 27, 2025. During November 1-30, 409 business tax renewals were processed, 86 new licenses issued, and 57 new certificates of use issued.

* New license refers to businesses that have either moved from one location to another, added an additional business use(s) or affiliated with a new professional with the business.

** New business refers to business entities establishing themselves for the first time in the City of Doral.
