

**RESOLUTION No. 26-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, TO ADOPT AND UTILIZE THE FLORIDA SHERIFFS ASSOCIATION COOPERATIVE PURCHASING PROGRAM FSA23-EQU21.1:EQUIPMENT EXTENSION PACKET FOR THE PURCHASE OF ANY AND ALL EQUIPMENT INCLUDING ALL TERRAIN AND UTILITY VEHICLES, WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V, OF THE CITY CODE OF ORDINANCES; IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral's Police Department seeks to adopt and utilize the Florida Sheriffs Association Cooperative Purchasing Program FSA23-EQU21.1:Equipment Extension Packet for the purchase of any and all equipment including all terrain and utility vehicles as needed to maintain operational efficiency throughout the City; and

**WHEREAS**, pursuant to Section 2-322 of the City Code, Staff respectfully requests that the City Council authorize the City Manager to adopt and utilize the Florida Sheriffs Association Cooperative Purchasing Program FSA23-EQU21.1:Equipment Extension Packet for the purchase of any and all equipment including all terrain and utility vehicles from any of the awarded vendors listed therein not to exceed budgeted funds; and

**WHEREAS**, Staff further requests the City Manager's Office respectfully requests authorization from the Mayor and City Councilmembers to utilize the Florida Sheriffs Association Cooperative Purchasing Program FSA23-EQU21.1:Equipment

Extension Packet (Exhibit A) and any subsequent renewals, in an amount not to exceed budgeted funds.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The purchase of any and all equipment including all terrain and utility vehicles in an amount not to exceed budgeted funds, via the Florida Sheriffs Association Cooperative Purchasing Program FSA23-EQU21.1:Equipment Extension Packet and their subsequent renewals, which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V, of the City Code is hereby approved.

**Section 3. Authorization:** The City Manager is authorized to utilize the Florida Sheriffs Association Cooperative Purchasing Program FSA23-EQU21.1:Equipment Extension Packet and their subsequent renewals to purchase any and all equipment including all terrain and utility vehicles in an amount not to exceed budgeted funds. This will be funded from the Capital Outlay- Vehicles Account #001.60005.500641 or other most appropriate account(s) as approved in the budget.

**Section 4. Implementation.** The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

**Section 5. Effective Date.** This Resolution shall take effect immediately

upon adoption.
