

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT AND THE USE OF THE CITY LOGO REQUESTED BY EDUARDO OROZCO ON BEHALF OF LEON SPORT CORP, TO HOST THE “GRAN FONDO GIRO D’ ITALIA” DEPARTING FROM DORAL CITY PLACE LOCATED AT 8300 NW 36 STREET ON A NINETY FIVE (95) MILES BIKE RIDE TRAJECTORY TAKING PLACE ON SATURDAY, FEBRUARY 7, 2026 AND SUNDAY, FEBRUARY 8, 2026 FROM 7:00 A.M. TO 2:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Eduardo Orozco (“Applicant”) on behalf of Leon Sport Corp (“Event Organizer”) seeks approval from the City of Doral (“City”) for a special event permit to host the “Gran Fondo Giro D’ Italia” cycling event at Doral City Place and the use of the City Logo as detailed in Exhibit “A”; and

WHEREAS, the purpose of this event is to bring to the City of Doral a premier cycling event that promotes health, wellness and community engagement; and

WHEREAS, staff has reviewed the application, attached hereto as Exhibit “A”, and recommends that the Mayor and City Council approve the proposed “Gran Fondo Giro D’ Italia” special event permit to be held on Saturday, February 7, 2026, and Sunday, February 8, 2026, from 7:00 a.m. to 2:00 p.m., subject to the conditions set forth herein.

NOW, THEREFORE, BE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The special event permit for the “Gran Fondo Giro D’ Italia” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
2. The Applicant shall be required to secure all inspections and approvals prior to the event date.
3. The Applicant is responsible for providing adequate security at the special event. The police department has provided an estimate for crowd control and traffic direction purposes.
4. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
5. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
6. The applicant should provide adequate parking for the attendees.
7. The Applicant shall comply with the City's noise ordinance.
8. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the Building Department.
9. All fees due must be paid within thirty (30) days upon special event permit approval. All fees must be paid by January 10, 2026. Total fees due for the "Gran Fondo D' Italia" special event are Seven Thousand Two Hundred Seventy Seven Dollars and 87/100 (\$7,277.87) which represents Six Thousand Nine Hundred Twelve Dollars and 87/100 (\$6,912.87) for Police services and Three Hundred Sixty Five Dollars and 00/100 (\$365.00) for Planning and Zoning and Technology fees.

Section 3. Effective Date. This Resolution shall become effective immediately upon its adoption.
