

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPROVE THE AGREEMENT FOR STATE FINANCIAL ASSISTANCE WITH THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT AGREEMENT No. PW008, IN THE AMOUNT NOT TO EXCEED THIRTY-SEVEN THOUSAND FIVE HUNDRED DOLLARS AND 00/100 (\$37,500.00) FOR THE DORAL POLICE DEPARTMENT AERIAL DRONE SUPPORT PROJECT; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Police Department has been awarded \$37,500.00 from the State of Florida, 2025-2026 General Appropriations Act: Aerial Drone Support Project, Award Agreement, Award No. PW008 and expend funds in an amount not to exceed \$37,500.00; and

**WHEREAS**, Staff respectfully requests that the Mayor and City Council approve the Agreement for State Financial Assistance between Florida Department of Law Enforcement and City of Doral, Award Agreement, Award No. PW008 for funds in the amount of \$37,500.00 as an award and expend funds in an amount not to exceed \$37,500.00 from expenditure account no. #001.60005.500658 for the Doral Police Department's Aerial Drone Support Project.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Manager hereby authorizes the Agreement for State Financial Assistance between Florida Department of Law Enforcement and City

of Doral, Award Agreement, Award No. PW008 from the 2025-2026 General Appropriations Act: Aerial Drone Support Project to receive the awarded funds in the amount of \$37,500.00 and expend funds from expenditure account no. #001.60005.500658 in an amount not to exceed \$37,500.00 to be used for the Doral Police Department.

**Section 3. Authorization:** The City Manager is hereby authorized to receive the awarded funds and expend said funds (reimbursable) on behalf of the City.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.
