## **RESOLUTION No. 25-**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN INTERLOCAL AGREEMENT WITH MIAMI-DADE COUNTY FOR THE PROVISION OF THE CITY OF DORAL ON-DEMAND TRANSIT SERVICE AT NO COST TO THE CITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") Public Works Department ("PWD") is continuously exploring ways to provide alternative modes of transportation options to its residents, employees, and visitors as a mean to improve mobility and reduce congestion, and

WHEREAS, the City offers an On-Demand Transit Service to address the immediate needs of first-last miles within the City limits; and

WHEREAS, the City's Mayor and Councilmember previously adopted a Resolution authorizing the City Manager to enter into an Interlocal with Miami-Dade County for the provision of the On-Demand Transit Service within the City limits; and

WHEREAS, staff is requesting to rectifying the previous adopted Resolution in order to allow the opportunity to hold a Public Hearing for the subject Interlocal Agreement, as required condition to the approval of the Interlocal Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> The Interlocal Agreement between the City of Doral and Miami-Dade County for the provision of the City's On-Demand Transit Service, is hereby approved.

<u>Section 3.</u> <u>Authorization</u>. The City Manager is authorized to execute the Interlocal Agreement with Miami-Dade County.

<u>Section 4.</u> <u>Implementation</u>. The City Manager and City Attorney are hereby authorized to take such action as may be necessary to implement the purpose and the provisions of this resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
