

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, SUPPORTING THE LAUNCH OF THE “DORAL SENIORS IT ACADEMY” PILOT PROGRAM TO ENHANCE DIGITAL INCLUSION FOR SENIOR RESIDENTS; DIRECTING THE CITY MANAGER TO COORDINATE PROGRAM IMPLEMENTATION AND HOST THE NEXT SENIOR CYBERSECURITY SEMINAR DURING THE UPCOMING HOLIDAY SEASON; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral remains committed to fostering community inclusion and improving the quality of life for residents of all ages; and

WHEREAS, the City recently hosted its first-ever Senior Cybersecurity Seminar through a partnership between the IT Department, Doral Police Department, and the Silver Club, which received strong participation and positive feedback from attendees; and

WHEREAS, the success of this initiative highlighted the continued need for educational programs that promote digital literacy and cybersecurity awareness among seniors; and

WHEREAS, Councilman Rafael Pineyro has proposed the establishment of a new pilot program, the “Doral Seniors IT Academy,” to expand upon this effort by providing quarterly digital literacy classes and biannual cybersecurity seminars for senior residents; and

WHEREAS, the program will also include an intergenerational volunteer component, engaging local high school and college students to assist senior participants and strengthen community bonds; and

WHEREAS, the foreseeable cost for this initiative includes a Five Thousand Dollar (\$5,000) consultant fee for the cybersecurity seminar, with additional costs for translation services to be determined; and

WHEREAS, the City Council finds that this initiative serves a valid public purpose by promoting digital inclusion, safety, and education within the City of Doral community.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

Section 1. Authorization. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Implementation. The City Manager is hereby directed to take all steps necessary to implement the terms of this Resolution including the disbursement of budgeted funds.

Section 3. Effective Date. This Resolution shall take effect immediately upon its adoption.
