

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE APPROVAL OF THE PARKS AND POLICE 4 KIDS, INC, BY LAWS; PROVIDING FOR APPOINTMENT OF BOARD OF DIRECTOR MEMBERS; PROVIDING FOR AUTHORITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on January 15, 2026, the City of Doral (the “City”) Council passed a resolution authorizing the restructuring of the Police and Parks 4 Kids, Inc (“PP4K”), foundation; and

WHEREAS, pursuant to the City’s resolution, on Wednesday, February 18, 2026, the Mayor and Council in their role as the interim PP4K Board met and approved revised by laws, which include new board of directors. True and correct copies of the approved and revised by-laws are enclosed as Exhibit “A”; and

WHEREAS, pursuant to Article VIII (Article XIV of the revised by laws), any and all revisions to the By-Laws must be approved by the City Council; and

WHEREAS, Article III, Section 2, of the revised by laws require that the Mayor appoint a member of the City Council and a Community Leader to serve as members of the PP4K Board, subject to ratification by the City Council; and

WHEREAS, the Mayor desires to appoint Councilwoman Nicole Reinoso to serve as the appointed Councilmember, and _____ to serve as the appointed Community Leader; and

WHEREAS, the Mayor and Council find that it is in the best interest of the City to approve this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Incorporation of Recitals. The aforementioned recitals are incorporated herein by reference.

Section 2. Approval. This Resolution is approved. The revised by-laws, herein enclosed as Exhibit "A", are hereby approved.

Section 3. Implementation. The City Manager and City Attorney are authorized to take all necessary steps to implement this Resolution. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 4. Appointments. Pursuant to Article III, Section 2, of the revised By Laws, the City Council hereby ratifies the Mayor's appointment of Councilwoman Nicole Reinoso, to fill the Council Member appointed role on the PP4K Board of Directors, and the appointment of Josh Rios, to fill the Community Leader role on the PP4K Board of Directors.

Section 5. Effective Date. This Resolution shall become effective immediately upon adoption.
