ITEM TITLE:

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE, AUTHORIZING THE CITY MANAGER TO UTILIZE THE COOPERATIVE AGREEMENT CONTRACT LDV, INC. PUBLIC SERVICES ID 11106, IN THE AMOUNT NOT TO EXCEED EIGHT HUNDRED AND FIFTY THOUSAND DOLLARS AND 00/100 (\$850,000.00) FOR THE PURCHASE OF THE MOBILE COMMAND VEHICLE AND EQUIPMENT; AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS FROM ACCOUNT No. 001.60005.500658 (\$750,000.00) AND ACCOUNT No. 105.60005.500641 (\$100,000.00); PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

BRIEF HISTORY:

The Police Department is seeking approval from the Mayor and City Councilmembers for the utilization of the Cooperative Agreement Contract- LDV, Inc.-Public Services ID 11106 for the purchase of the Mobile Command Vehicle and equipment to be purchased from LDV, Inc. The City is seeking a waiver of competitive bidding.

The Police Department was awarded \$750,000.00 from the 2025-2026 General Appropriations Act: Doral Police Department Mobile Command Vehicle, Award Number PW009 per Resolution No. 25-249. The final project cost exceeded the original budget by approximately \$100,000, resulting in a total cost of \$850,000.

The increase affected both the base vehicle and the specialized upfitting required to meet operational and safety standards. The Mobile Police Command Post required customized build features to ensure it meets emergency response, interoperability, and operational readiness requirements.

The mobile command vehicle will be operated throughout the City of Doral and any satellite cities within the Doral Divisional Emergency Operations Center. The mobile command vehicle will be equipped with the necessary equipment to provide operational, communication, and logistical support during major incidents and natural disasters.
