#### **Introduction**

Cici Avelar (the "Applicant") is requesting approval of a special event from the Mayor and the City Council to host the "LIV Golf Invitational-Miami @Trump National Doral", a golf tournament event, pursuant to Chapter 35 of the City Code of Ordinances ("City Code"). The proposed event will be hosted at Trump National Doral, 4400 NW 87 Avenue, Doral, FL 33178, from Friday, April 4, 2025, thru Sunday, April 6, 2025, from 9:00 am to 9:00 pm. The requested set-up period is from March 1, 2025, to April 30, 2025.

A copy of the application is provided in "Exhibit A".

#### **Background**

The purpose of this event is to modernize and supercharge the game of professional golf through expanded opportunities for both players and fans alike. This event will showcase the City of Doral as an international city. This event will attract golf fanatics and tourists to visit the area and will have a positive economic impact on the city and regional economies. The local industries that

will benefit the most from this event will be the service (i.e. transportation, arts, entertainment, recreation, and retail services), retail and hospitality sectors (i.e. hotels).

The Applicant estimates approximately ten thousand (10,000) attendees during the duration of the event, pursuant to Chapter 35 of the City Code of Ordinances ("City Code") events that expect four (400) or more attendees shall require the approval of the city council.

The applicant has successfully hosted events in the City of Doral in previous years.

- 1. LIV Golf Series in 2023 and other eight domestic and international events.
- 2. The Team Championship at Trump National Doral, April 2024 (Est. attendance 8,000)

Attendance is estimated at 10,000 participants during the event.

## Sponsorship/Use of City Logo

The Applicant is not requesting the use of the city logo. No financial assistance has been requested by the applicant.

#### **Road Closures**

The Applicant is requesting public road closures, as follows:

One (I) right lane, NW 36 Street, right hand lane by the Trump Spa.

Road closure will be from April 4, 2025, through April 6, 2025, during the hours of 7:00 am to 9:00 pm. A Maintenance of Traffic (MOT) permit approval is required from Miami Dade County Department of Transportation and Public Works, City of Doral prior to the event date.

#### **Parking**

There is on-site parking available at the designated park. Overflow parking should be coordinated by the applicant according to the Parking Plan provided as follows:

Shuttle Bus Dropoff

Citi Bank Parking, 8750 NW 36 Street, Doral, FL – UBER Pick up and Drop off

Parking is available on the 52nd Terrace and approximately 82nd Avenue area.

## **Attendance**

The Applicant estimates approximately 10,000 attendees during the entirety of the event. Events that expect 400 or more attendees shall require the approval of the City Council, pursuant to City Code Section 35-20(d).

#### Fiscal Impact

The fiscal impact on the city is \$184,299.60. Applicants will pay City fees and expenses totaling \$184,299.60 \$183,934.60 for Police services and \$365.00 for Planning and Zoning and Technology fee.
