

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AMENDING RESOLUTION No. 25-39 TO SPECIFY THAT THE SERGEANT-AT-ARMS POSITION SHALL BE ASSIGNED SOLELY FOR THE PROTECTION AND SECURITY OF THE MAYOR; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on January 27, 2025, the City Council adopted Resolution No. 25-39 approving, among other things, the creation of the Sergeant-at-Arms position for the City of Doral; and

**WHEREAS**, the City Council finds it appropriate and necessary to clarify that the Sergeant-at-Arms position shall be assigned solely for the protection, security, and transportation coordination of the Mayor during official City meetings, events, and related activities; and

**WHEREAS**, the City Council wishes to amend Resolution No. 25-39 to reflect this clarification;

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Amendment.** Resolution No. 25-39 is hereby amended to specify that the Sergeant-at-Arms position shall be dedicated solely to providing security, transportation coordination, and safety-related duties for the Mayor of the City of Doral, in accordance with the job description approved in Resolution No. 25-39, as may be amended from time to time.

**Section 3. Implementation.** The City Manager, Chief of Police, and City Attorney are hereby authorized to take all necessary actions to implement the intent and provisions of this Resolution, including modifying the job description consistent with this amendment.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
