A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDING REQUEST FOR PROPOSALS #2024-21 "RECREATION AND FITNESS PROGRAMS" TO THE TOP RANKED FIRMS, AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AGREEMENTS WITH GREISY'S TOTAL TRAINING; PILAFIT; FEEL WELL TRAIN BETTER; MS. SARA MUSIC FOR BABIES; REGINA DE LOS SANTOS SALSA & BACHATA; PINECREST DANCE: ADY & COMPANY. INC.: AND LEVEL UP FOR THE MOBILE GYM, PROVISION OF RECREATIONAL PROGRAMMING FOR A PERIOD OF ONE (1) YEAR WITH THE OPTION TO RENEW FOR AN ADDITIONAL TWO (2) ONE (1) YEAR TERMS: PROVIDING FOR IMPLEMENTATION: PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN **EFFECTIVE DATE**

WHEREAS, the City of Doral (the "City") issued Request for Proposals (RFP) #2024-21 "Recreation and Fitness Programs" on November 12, 2024, for the provision of recreation and fitness programming services; and

WHEREAS, through our advertising on social media new vendors reached out to the Parks and Recreation department to offer their fitness and recreational programming after the bid process had been completed; and

WHEREAS, providing additional recreation and fitness programming is essential to the success of Doral Central Park Community & Fitness Center and will be incorporated into the monthly facility membership; and

WHEREAS, the City and the providers will split the revenue generated from program registration on a 75%-70% / 25%-30% split (75%-70% provider / 25%-30% City) or paid on an hourly or per-class rate instead of a revenue share. Registration fees will either be collected by the providers or the City. Revenue will be deposited into GL account 001.9000.347405 (Recreation—Community Center), and program expenses will be paid from account 001.90005.500340 (Contractual Services), not exceeding budgeted

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The Mayor and City Councilmembers hereby approve authorize the City Manager to negotiate and enter into agreements with Greisy's Total Training, Pilafit, Feel Well Train Better, Ms. Sara Music for Babies, Regina de Los Santos Salsa & Bachata, Pinecrest Dance, Ady & Company, Inc., & Level Up Mobile Gym. The agreements shall be for a period of one (1) year pilot program with the option to extend for an additional two (2) one (1) year renewals, subject to approval by the City Attorney as to form and legal sufficiency

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
