A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO **EXECUTE A WORK ORDER WITH MARLIN ENGINEERING INC. FOR** PROFESSIONAL ENGINEERING SERVICES RELATED TO THE DESIGN AND PERMITTING OF ROADWAY AND DRAINAGE IMPROVEMENTS ALONG NW 104 AVENUE FROM NW 68 STREET TO VINTAGE PLACE CONDOMINIUM ENTRANCE, IN AN AMOUNT NOT TO EXCEED NINETY-SIX THOUSAND EIGHT HUNDRED SEVENTY DOLLARS AND NINE CENTS (\$96,870.09); AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY: **PROVIDING FOR IMPLEMENTATION: PROVIDING FOR** INCORPORATION OF RECITALS; AND PROVIDING FOR AN **EFFECTIVE DATE**

WHEREAS, the Public Works Department (PWD) needs to secure a firm to provide the services identified for the project entitled "Roadway and Drainage Improvements for NW 104th Avenue from NW 68th Street to Vintage Place condominium entrance"; and

WHEREAS, Marlin Engineering Inc. (Marlin) is a pre-qualified provider of professional engineering services selected by Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council on June 3, 2024, via Resolution 24-54; and

WHEREAS, in July of 2025, the PWD requested a proposal from Marlin to provide professional services for the design and permitting phase of entitled "Roadway and Drainage Improvements for NW 104th Avenue from NW 68th Street to Vintage Place condominium entrance": and

WHEREAS, this project will consist of the design and permitting phase of the missing northbound lane along NW 104th Avenue from NW 68th Street to the entrance Vintage Place Condominium to complete the roadway cross section; and

WHEREAS, the Project includes roadway widening adjacent to the Doral 10 vacant land, sidewalk on the east side of the road, drainage improvements, signage, and pavement markings; and

WHEREAS, the contract between Marlin and the City of Doral was procured through the publicly advertised Invitation to Bid (ITB) 2023-08 process to select a pool of pre-qualified Engineering and Architecture firms; and

WHEREAS, this group of eleven (11) firms was approved by the Mayor and City Councilmembers during the March 2024 Council meeting via Resolution No. 24-54 (approved 5-0); and

WHEREAS, the PWD respectfully requests authorization from the Mayor and the City Councilmember to authorize the City Manager to execute Work Order No. 9 with Marlin Engineering, enclosed as part of Exhibit "A", for design and permitting phase for Roadway and Drainage Improvements for NW 104th Avenue from NW 68th Street to Vintage Place condominium entrance, in an amount not to exceed Ninety Six Thousand, Eight Hundred Seventy Dollars and 09/100 (\$96,870.09); and

WHEREAS, funding for this request is available from the Public Transportation Fund – Construction in Progress, Account No. 101.80005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Work Order No. 9 between the City of Doral and Marlin Engineering Inc. to provide the design and permitting work relating to "Roadway and Drainage Improvements for NW 104th Avenue from NW 68th Street to Vintage Place condominium entrance", in an amount not to exceed Ninety Six Thousand, Eight Hundred Seventy Dollars and 09/100 (\$96,870.09), a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the work order and expend budgeted funds on behalf of the City.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
