Summary of the proposed ordinance and statement of public purpose<sup>1</sup>:

This proposed ordinance seeks to adopt elements of the recently adopted Florida Statute 715.075 into Chapter 44 of the City of Doral’s Code of Ordinances. The public purpose of this ordinance is to provide additional regulation of signage within private property, particularly parking used for motor vehicle parking, to ensure uniformity and protect the City’s aesthetics.
