A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A WORK ORDER WITH CHA CONSULTING INC. FOR PROFESSIONAL ENGINEERING SERVICES RELATED TO THE DESIGN AND PERMITTING OF ROADWAY AND DRAINAGE IMPROVEMENTS AT FOUR (4) SEPARATE LOCATIONS, IN AN AMOUNT NOT TO EXCEED ONE HUNDRED SEVEN THOUSAND ONE HUNDRED SEVENTY-EIGHT DOLLARS AND SIXTY-FOUR CENTS (\$107,178.64); AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR THE INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") Public Works Department (PWD) needs to secure a firm to provide the services identified for the project entitled "Roadway and Drainage Improvements at four (4) separate locations; and

WHEREAS, CHA Consulting Inc. (CHA) is a pre-qualified provider of professional engineering services selected by Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council on June 3, 2024, via Resolution 24-54; and

WHEREAS, in September of 2025, the PWD requested a proposal from CHA to provide professional services for the design and permitting phase of entitled "Roadway and Drainage Improvements at four (4) separate locations; and

WHEREAS, this project covers the design and permitting phase at four locations: NW 88th Avenue and NW 15th Street, NW 89th Court and NW 13th Terrace, NW 109th Avenue and NW 51st Street, and NW 114th Avenue and NW 43rd Terrace; and

WHEREAS, work will include milling and resurfacing, installation of concrete sidewalks and driveways, ADA curb ramps, signage, pavement markings, and related drainage improvements at each site; and

WHEREAS, the contract between CHA Consulting, Inc. (CHA) and the City of Doral was procured through the publicly advertised Invitation to Bid (ITB) 2023-08 process to select a pool of pre-qualified Engineering and Architecture firms; and

WHEREAS, this group of eleven (11) firms was approved by the Mayor and City Councilmembers during the March 2024 Council meeting via Resolution No. 24-54 (approved 5-0); and

WHEREAS, the PWD respectfully requests authorization from the Mayor and the City Councilmember to authorize the City Manager to execute Work Order No. 5 enclosed as part of "Exhibit A" for design and permitting phase to Roadway and Drainage Improvements at four (4) separate locations, in an amount not to exceed \$107,178.64; and

WHEREAS, funding for this request is available in the Public Stormwater Fund – Construction in Progress, Account No. 401.80005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> The work Order No. 5 between the City of Doral and CHA Consulting Inc. to provide the design and permitting phase "Roadway and Drainage Improvements at four (4) separate locations in an amount not to exceed \$107,178.64, a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to execute the work order and expend budgeted funds on behalf of the City.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution, additionally, the City Manager and City Attorney are authorized to execute any amendments, supplements, or any other documents necessary to effectuate this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
