

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT BY CLAUDIA ROJAS ON BEHALF OF THE DORAL ISLES COMMUNITY ASSOCIATION TO HOST THE “DORAL ISLES COMMUNITY 5K RUN & WALK” SPECIAL EVENT AT 6450 NW 110 AVENUE, DORAL, FL 33178, ON APRIL 26, 2026, FROM 7:00 A.M. TO 11:00 A.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Claudia Rojas (the “Applicant”) on behalf of Doral Isles Community Association (the “Event Organizer”) seeks approval from the City of Doral (“City”) to host the “Doral Isles Community 5K Run & Walk” special event at 6450 NW 110 Avenue, exclusively within the private roads of the Doral Isles Community, along NW 60 Street, extending to NW 110 Avenue and NW 72 Street, as detailed in Exhibit “A”; and

WHEREAS, the event will consist of a recreational run/walk event open exclusively to the residents of the Doral Isles Community; and

WHEREAS, staff recommends that the Mayor and City Council approve the proposed “Doral Isles Community 5K Run & Walk” special event permit to be held on Sunday, April 26, 2026, from 7:00 a.m. to 11:00 a.m., subject to the conditions set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The special event permit for the “Doral Isles Community 5K Run & Walk” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the City.
2. The Applicant shall be required to secure all inspections and approvals prior to the event date.
3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the City's Building Department.
4. The Applicant is responsible for providing adequate security at the special event.
5. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
6. The Applicant should provide adequate parking for the attendees.
7. The Applicant shall comply with the City's noise ordinance.
8. All fees due must be paid no later than 14 days in advance of the event. All fees must be paid by April 12, 2026. Total fees due for "Doral Isles Community 5K Run & Walk" special event are \$1,015.00 which represents for Planning and Zoning and Technology fees.

Section 3. Effective Date. This Resolution shall become effective immediately upon its adoption.

Section 4. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.
