

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, APPROVING THE PURCHASE OF TWO (2) NEW POLICE VEHICLES VIA THE AGREEMENT BETWEEN SOURCEWELL CONTRACT No. 091521-NAF AND ALAN JAY FLEET SALES, WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V, OF THE CITY'S CODE IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, two (2) new vehicles are needed to replace two (2) Police total loss units, Unit 436 and Unit 2203; and

WHEREAS, the City of Doral (the "City") Public Works Department (PWD) respectfully requests authorization from the Mayor and the City Councilmembers to authorize the City Manager to purchase two (2) Chevy Tahoe LS vehicles from Alan Jay Fleet via the Sourcewell Contract, Contract No. 091521-NAF, which was competitively entered into in a matter similar to that set forth in Chapter 2, Article V of the City Code; and

WHEREAS, Staff also requests authorization for the City Manager to proceed with the necessary retrofit for the proposed vehicles; and

WHEREAS, funding for this request is available in the current Fiscal Year in the Fleet Replacement Fund, "Capital Outlay – Vehicles" Account, Account No. 304.50005.500641.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The use of the Sourcewell Contract No. 091521-NAF contract, which was competitively entered into in a matter similar to that set forth in Chapter 2, Article V of the City Code, for the purchase of two (2) Chevy Tahoe LS from the Public Works Fund “Capital Outlay – Vehicles” Account Number 304.50005.500641 in amount not to exceed budgeted funds, is hereby approved.

Section 3. Authorization. The City Manager is authorized to purchase the vehicle and expend budgeted funds on behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.
