

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE MEMORANDUM OF UNDERSTANDING WITH ROLLKALL TECHNOLOGIES, LLC FOR THE EXTRA-DUTY SOFTWARE; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, RollKall Technologies, LLC will provide administrative and operational management service to Doral Police Department with all extra duty services; and

**WHEREAS**, the Doral Police Department can leverage the RollKall software to manage the jobs, scheduling, invoicing and reporting; utilizing the software as needed; and

**WHEREAS**, RollKall Technologies, LLC will also provide a hybrid solution where it fully manages a designated group of vendors, while the Doral Police Department retains control over the rest of the vendors using the RollKall platform.

**WHEREAS**, Staff has recommended that the City Council approve the Memorandum of Understanding between RollKall Technologies, LLC and the City of Doral Police Department, in substantially the form attached hereto as Exhibit "A".

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The Memorandum of Understanding between RollKall Technologies, LLC and the City of Doral Police Department, in substantially the same form attached hereto as Exhibit "A", is hereby approved. The City Manager is hereby authorized to execute the Memorandum of Understanding on behalf of the City subject to approval as to form and legal sufficiency by the City Attorney.

**Section 3. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
