A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING MUNICIPAL SPONSORSHIPS TO AMOR Y FUERZA HONDURAS IN THE AMOUNT OF FIVE HUNDRED DOLLARS AND 00/100 (\$500.00); FRIENDS UNITED IN THE AMOUNT OF FIVE HUNDRED DOLLARS AND 00/100 (\$500.00); TOYS FOR KIDS MIAMI IN THE AMOUNT OF FIVE HUNDRED DOLLARS AND 00/100 (\$500.00); AND ASSOCIATION OF OCOENOS RESIDING IN FLORIDA INC IN THE AMOUNT OF FIVE HUNDRED DOLLARS AND 00/100 (\$500.00); PURSUANT TO SECTION 2-79 OF THE CITY'S CODE OF ORDINANCES; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-79 of the Code of Ordinances for the City of Doral governs municipal sponsorships and provides that each Council member is allotted \$5,000 per fiscal year to sponsor special events for eligible applicants whose events and programs support the city's mission and provide a community benefit; and

WHEREAS, Amor y Fuerza Honduras is a nonprofit organization that provides charitable and community support services, and seeks sponsorship to continue its outreach efforts; and

WHEREAS, Friends United is a nonprofit organization that supports community-based programming and service initiatives, and seeks sponsorship to continue its efforts; and

WHEREAS, Toys for Kids Miami is a nonprofit organization dedicated to supporting children and families in need and seeks sponsorship to continue its charitable work; and

WHEREAS, Association of Ocoenos Residing in Florida Inc is a nonprofit organization recognized as tax-exempt under Section 501(c)(3) of the Internal Revenue

Code and seeks sponsorship to continue its community support and charitable services;
and

WHEREAS, these nonprofit organizations' efforts align with the City of Doral's mission to enhance the welfare and quality of life for all residents; and

WHEREAS, the sponsorships will aid these organizations in continuing their vital work within the community;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

Section 1. Authorization. The City of Doral hereby authorizes municipal sponsorships in the amounts of:

- Amor y Fuerza Honduras – \$500.00
- Friends United – \$500.00
- Toys for Kids Miami – \$500.00
- Association of Ocoenos Residing in Florida Inc – \$500.00

pursuant to Section 2-79 of the City's Code of Ordinances.

Section 2. Implementation. The City Manager is hereby directed to take all steps necessary to implement the terms of this Resolution including the disbursement of funds consistent with the City's fiscal policies.

Section 3. Effective Date. This Resolution shall take effect immediately upon its adoption.
