

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY PEDRO DE LA CRUZ, TO HOST THE “2025 MIAMI INTERNATIONAL TAEKWONDO CAMP” EVENT AT DORAL LEGACY PARK LOCATED AT 11400 NW 82 STREET FROM SATURDAY, AUGUST 30, 2025, TO SUNDAY, AUGUST 31, 2025 FROM 9:00 A.M. TO 6:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS** Pedro De La Cruz (the “Applicant”) seeks approval from the City of Doral to host the “2025 Miami International Taekwondo” special event at the Doral Legacy Park located at 11400 NW 82 Street, Doral, Florida, 33166, and

**WHEREAS** the purpose of this event is to promote a healthy lifestyle, discipline and provide an Olympic level training to all participants; and

**WHEREAS** staff recommends that the Mayor and City Council approve the proposed “2025 Miami International Taekwondo” special event permit to be held from Saturday, August 30, 2025, to Sunday, August 31, 2025, from 9:00 a.m. to 6:00 p.m.

**NOW, THEREFORE, BE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

**Section 2. Approval.** The special event permit for the “2025 Miami International Taekwondo Camp” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
2. The Applicant shall be required to secure all inspections and approvals prior

to the event date.

3. The Applicant is responsible for providing adequate security at the special event. The police department has provided an estimate for crowd control and traffic direction purposes.
4. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
5. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
6. The applicant should provide adequate parking for the attendees.
7. All fees due must be paid within thirty days upon special event approval. All fees must be paid by September 13, 2025. Total fees due for 2025 Miami International Taekwondo special event are Seven Thousand, Seven Hundred Fourteen Dollars and 52/100 (\$7,714.52), of which One Thousand Three Hundred Eighty One Dollars and 66/100 (\$1,381.66) are for Police services, Three Hundred Sixty Five Dollars and 00/100 (\$365.00) are for Planning and Zoning services, and Five Thousand, Four Hundred Sixty Seven Dollars and 66/100 (\$5,467.66) are for Technology fees, Park rentals and security deposit.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon its adoption.
