

5. Approach and Methodology

a. Technical Approach

Current Permissions Review

Deploy and run proprietary tools to discover current permission profiles and access events at the folder level where available

Historic Access Reviews

The KirkpatrickPrice team will evaluate the current location of historic logs that would provide information regarding historic access records. If these logs are aggregated the team would evaluate the ability for this aggregation point to support the queries required to illuminate historic access to the file shares. If this data exists across multiple systems the team at Kirkpatrick-Price would aggregate them to a central repository, such as elastic search. Aggregating the available logs would serve two purposes. First it would allow for querying and analysis of historic access logs for the requested engagement. Also, this infrastructure would provide the City of Doral with the ability to continue collecting cybersecurity data from core systems to facilitate future requirements for investigation.

Analysis of collected data

Once available logs are aggregated KirkpatrickPrice will develop custom queries to determine the following:

- Access attempts of the in-scope folders.
- Permission modifications and / or attempts to make permission modifications.

Validation of Security Controls

KirkpatrickPrice will conduct penetration testing to validate that security controls are protecting the environment from unauthorized access and permissions modification.



Reporting

Project reporting will occur on two levels. First, a weekly update to the project sponsors at City of Doral will be sent by the Project Manager for KirkpatrickPrice by email. Items to be reported will include progress against the scope, actual schedule against planned schedule, and any issues that have been uncovered and their status. The second level of reporting will include a bi-weekly virtual meeting with the designated project stakeholders/sponsors from both organizations to ensure the project is proceeding according to expectations and discuss any concerns from either party. Additionally, project team members will raise any issues or findings deemed critical immediately to the KirkpatrickPrice project manager who will analyze and document the issue for confidential discussion with designated City of Doral stakeholders/sponsors no later than 24 hours from discovery for a discussion and decision regarding possible impacts or disruptions.
