



CITY OF DORAL COUNCIL MEETING MEMORANDUM

ITEM TITLE:

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO PHASE-OUT THE VEHICLES, EXECUTE THE VEHICLE TITLES, AND PROCEED WITH THE AUCTIONING OF THE VEHICLES INCLUDED IN EXHIBIT "A"; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

DEPARTMENT RECOMMENDATION:

Approval

BRIEF HISTORY:

In order to maintain an adequate and efficient fleet size that can provide the City with the proper level of service, the Fleet Maintenance Division recommends the auction of City vehicles that are no longer needed or in use. This recommendation is based on a life cycle analysis, industry standards, and cost-effective repairs. To achieve the optimal use of every vehicle and equipment, the Fleet Maintenance Division suggests the adequate time to surplus vehicles or equipment with the understanding of the needs of each City department, and the goal of reducing capital investment while still being able to complete the required responsibilities and tasks.

On October 8, 2025, the Mayor and the City Councilmembers adopted Resolution No. 25-252 (approved 5-0), authorizing the adoption of the City of North Miami contract with Bidera LLC for auction surplus services.

The Public Works Department (PWD) respectfully request that the Mayor and the City Councilmembers authorize the auction of the vehicles listed on Exhibit "A".

The City vehicles to be auctioned through this contract are being auctioned as a result of vehicle age, mileage, engine hours, maintenance costs, and department's vehicle need. The vehicles listed on Exhibit "A" are ready to be auctioned by Bidera LLC due to one or a combination of the reasons stated above. All City decals, logos, and equipment will be removed from each vehicle listed. A total of 16 vehicles and additional equipment will be auctioned. The process of vehicle surplus allows the City to recoup money while the vehicle has a commercial value.
