BRIEF HISTORY:

Introduction

The City of Doral Police Department has been awarded Seven Hundred Fifty Thousand Dollars and 00/100 (\$750,000.00) from the 2025-2026 General Appropriations Act: Mobile Command Vehicle, Award Number PW009. The goal of this funding opportunity to provide operational and logistical support during major incidents and natural disasters.

Background

The City of Doral Police Department was awarded Seven Hundred Fifty Thousand Dollars and 00/100 (\$750,000.00) from the 2025-2026 General Appropriations Act: Doral Police Department Mobile Command Vehicle, Award Number PW009. The mobile command vehicle will be operated throughout the City of Doral and any satellite cities within the Doral Divisional Emergency Operations Center. The mobile command vehicle will be equipped with the necessary equipment to provide operational, communication, and logistical support during major incidents and natural disasters.
