## **RESOLUTION No. 25-**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ADOPTING THE CITY OF DORAL 2026 LEGISLATIVE PRIORITIES; PROVIDING FOR TRANSMITTAL TO THE GOVERNOR'S OFFICE, FLORIDA SENATE, FLORIDA HOUSE OF REPRESENTATIVES, AND MIAMI-DADE COUNTY LEGISLATIVE DELEGATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS,** the City of Doral (the "City") recognizes the importance of advocating for legislative priorities that protect and enhance the health, safety, welfare, and quality of life of its residents; and

**WHEREAS,** on October 16, 2025, the Mayor and Council held a public, legislative priorities workshop to deliberate the City's legislative priorities for fiscal year 2025-2026; and

WHEREAS, as a result of its discussions, the Mayor and Council have identified key legislative priorities for the 2025-2026 legislative session, which includes the preservation of home rule, property tax relief, transportation and mobility improvements, housing affordability, public safety, and other critical issues impacting the City and its residents. A summary of the 2025-2026 legislative priorities is attached hereto as Exhibit "A": and

WHEREAS, the Mayor and Council desires to formally adopt these legislative priorities to guide the City's advocacy efforts and to communicate these priorities to Miami-Dade County Commissioners and State Legislators; and

WHEREAS, The City Council finds that adopting the 2025-2026 Legislative Priorities is in the best interest of the City of Doral and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1. Recitals.</u> The foregoing recitals are true and correct and are incorporated herein by this reference as if fully set forth in this section.

<u>Section 2. Adoption of Legislative Priorities.</u> The City Council hereby adopts the 2026 Legislative Priorities for the City of Doral, as attached hereto as Exhibit "A" and incorporated herein by reference.

<u>Section 3. Approval.</u> The City Council hereby approves the 2026 Legislative Priorities, as attached hereto as Exhibit "A", and authorizes the City Manager and City Attorney to take all necessary actions to implement this Resolution.

Section 4. Transmission. The City Clerk is directed to transmit a copy of this Resolution, along with the 2026 Legislative Priorities, attached hereto as Exhibit "A" to Miami-Dade County, the Florida Legislature, the Governor's Office, and other relevant state and federal agencies and stakeholders.

<u>Section 5. Effective Date.</u> This Resolution shall take effect immediately upon its adoption.
