

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, INSTRUCTING THE CITY ATTORNEY TO AMEND CITY ORDINANCES TO CREATE MICROMOBILITY ORDINANCES IN CONFORMANCE WITH FLORIDA STATUTES § 316.2128 AND § 316.2065 IN ORDER TO REQUIRE AGE RESTRICTION, AMEND SAFETY GEAR REQUIREMENTS AND ENFORCEMENT AS THEY RELATE TO THE OPERATION OF MICROMOBILITY DEVICES; PROVIDING CITY ATTORNEY WITH INSTRUCTION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”) is a highly urbanized municipality where many of its residents rely on alternative modes of transportation that include micro-mobility devices; and

**WHEREAS**, micro-mobility devices include automated scooters and bicycles that can exceed twenty-five (25) miles per-hour; and

**WHEREAS**, during the October 2024 City Council meeting, Councilman Pinyero proposed, and the City Council adopted a resolution urging the State of Florida’s legislature convened for the 2025 legislative session to enact amendments to Florida Statute § 316.2128 and 316.2065 in order to provide the City with authority to regulate the use of micromobility devices operating within the City’s corporate limits; and

**WHEREAS**, prior to the 2025 State of Florida legislative session, Florida Statutes § 316.2128 and 316.2065, provided prescriptive regulations regarding the age and safety equipment that micromobility devices where required to meet; and

**WHEREAS**, due in part to the City's action, the State legislature adopted Senate Bill 462 which was signed into law by Governor DeSantis and provides the City with greater control to regulate age and safety equipment; and

**WHEREAS**, the City desires to adopt legislation that will require age limits and security requirements for all persons desiring to operate micromobility devices within the City limits; and

**WHEREAS**, the Mayor and City Council finds that it is in the City's best interest to instruct the City Attorney to draft legislation in conformity with Senate Bill 462 that adopts local restrictions on age limitations and creates safety regulations for the operations of micromobility devices within City limits.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Instructing City Attorney to Draft Legislation Creating City Regulation Regarding the Operation of Micromobility Devices** The Mayor and Councilmembers of the City of Doral approve this Resolution and instruct the City Attorney to draft an Ordinance requiring age restriction and safety regulations for all persons operating micromobility devices on City of Doral rights of way.

**Section 3. Instructing the City Attorney and City Chief of Police to Create a Schedule of Fines.** The City Attorney and Chief of Police shall work together to create a schedule of fines relating to violations of the City's adopted Ordinance regarding the age

restrictions and safety regulations for all person operating micromobility devices on the City of Doral Rights of Way.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
