



## **CITY OF DORAL COUNCIL MEETING MEMORANDUM**

### **ITEM TITLE:**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO A SERVICE AGREEMENT EXTENSION WITH ZONAR (FORMERLY KNOWN AS TRACKING SOLUTIONS CORPORATION) FOR THE INSTALLATION AND SERVICES OF SAFETY AND SECURITY DEVICES ON THE DORAL TROLLEY SYSTEM (DTS) FOR AN EIGHT MONTH PERIOD, IN AN AMOUNT NOT TO EXCEED ANNUAL BUDGETED FUNDS, UNDER THE SAME TERMS AND CONDITIONS OF THE CURRENT CONTRACT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE CONTRACT EXTENSION AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

### **BRIEF HISTORY:**

On August 30, 2010, the Mayor and City Councilmembers adopted Resolution No. 10-46, (approved 4-0, 1 absent) authorizing the City Manager to enter into a five (5) year contract with two (2) one-year (1) options to extend with Tracking Solutions Corp (TSO Mobile) currently known as Zonar Systems, for the installation and services of safety and security devices on the Doral Transit System (DTS). The vendor uses the tracking equipment located in each trolley to provide real time position data and other vehicle information. The City executed the final contract extension for TSO Mobile which expired on August 30, 2017.

At the June 2017 City Council Meeting, the Mayor and City Councilmembers adopted Resolution No. 17-110, (approved 5-0) authorizing City Staff to extend the Contract Agreement with TSO Mobile on a month-to-month basis. The contract extensions were under the same terms and conditions of the original Contract, while City Staff negotiated a new five (5) year Contract Agreement with TSO Mobile that would include competitive unit prices for equipment, installation, and monthly services. On January 9, 2019, the new agreement was approved by the Mayor and the City Councilmembers via Resolution No. 19-21 (approved 5-0), for a two (2) year period with three (3) additional one (1) year extension options. The third one (1) year renewal term expired on February 28, 2024.

At the January 15, 2025, City Council Meeting, the Mayor and City Councilmembers adopted Resolution No. 25-18, (approved 4-0, 1 absent) authorizing City Staff to extend the Contract

Agreement with TSO Mobile for a one-year extension under the same terms and conditions of the original Contract.

The PWD along with the Procurement Division is diligently researching the market to determine if there is another viable vendor that can meet the Doral Trolley program's safety and security goals while a Request for Proposals (RFP) is being developed. As such, the PWD is requesting to enter into a Service Agreement extension with Zonar Systems (formerly TSO Mobile) for the Installation and Services of safety and security devices on the DTS while maintaining the terms and conditions of the current contract, for an eight (8) month period, so as to match the current duration of the DTS current Operation & Maintenance contract.
