

**RESOLUTION No. 26-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT AND USE OF THE CITY LOGO REQUESTED BY DANIEL LORENZO ON BEHALF OF GOAT MEDIA PRODUCTIONS TO HOST THE “DOWNTOWN DORAL ARTS AND MUSIC FESTIVAL” AT 5357 NW 87 AVE DORAL, FL 33166, ALONG NW 53 STREET BETWEEN NW 87 AVENUE AND NW 84 AVENUE, FROM JANUARY 30, 2026 TO FEBRUARY 1, 2026, FROM 10:00 A.M. TO 11:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Daniel Lorenzo (the “Applicant”) on behalf of Goat Media Productions (the “Organizer”) seeks approval from the City of Doral (the “City”) for a special event permit and use of the City logo to host the “Downtown Doral Arts and Music Festival” special event at 5335 NW 87 Avenue, specifically along NW 53 Street between NW 87 Avenue and NW 84 Avenue as detailed in Exhibit “A”; and

**WHEREAS**, the proposed special event will provide cultural and recreational opportunities for residents and visitors, while also generating positive economic impacts for local businesses and enhancing brand visibility for participating sponsors and vendors; and

**WHEREAS** staff has reviewed the application, attached hereto as Exhibit “A”, and recommends that the Mayor and City Council approve the proposed “Downtown Doral Arts and Music Festival” special event permit to be held from January 30, 2026 to February 1, 2026, from 10:00 a.m. to 11:00 p.m.

**NOW, THEREFORE, BE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

**Section 2. Approval.** The special event permit for the “Downtown Doral Arts and Music Festival” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
2. The Applicant shall be required to secure all inspections and approvals prior to the event date.
3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the Building Department.
4. The Applicant is responsible for providing adequate security at the special event. The police department has provided an estimate for crowd control and traffic direction purposes.
5. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
6. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
7. The applicant should provide adequate parking for the attendees.
8. The Applicant shall comply with the City’s noise ordinance.
9. The payment for all required fees and costs shall be required no later than 14 days in advance of the event. All fees must be paid by January 16, 2026. Total fees due for the Downtown Doral Arts and Music Festival special event are \$48,701.02. which represents \$47,936.02 for Police services and \$765.00 for Planning and Zoning and Technology fees.

**Section 3. Effective Date.** This Resolution shall become effective immediately

upon its adoption.

**Section 4. Implementation.** The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.
