

**RESOLUTION No. 24-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A MUTUAL AID AGREEMENT WITH THE SOUTH FLORIDA HIGH INTENSITY DRUG TRAFFICKING AREA (HIDTA), TO HAVE AUTHORITY TO DISMANTLE AND DISRUPT THE ORGANIZATIONS COMMITTING SUCH VIOLATIONS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the South Florida High Intensity Drug Trafficking Area-HIDTA and the City of Doral have the authority to dismantle and disrupt the organizations committing such violations; and

**WHEREAS**, the Strike Force is investigate and illegal money laundering and drug trafficking operations and related crimes, in an effort to dismantle and disrupt the organizations committing such violations; and

**WHEREAS**, Staff has recommended that the City Council approve a Mutual Aid Agreement between the South Florida High Intensity Drug Trafficking Area-HIDTA and the City of Doral, Florida to dismantle and disrupt the organizations committing such violations.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The Mutual Aid Agreement between the South Florida High Intensity Drug Trafficking Area-HIDTA and the City of Doral, attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, is hereby approved. The City Manager is hereby authorized to execute the Mutual Aid

Agreement on behalf of the City subject to approval as to form and legal sufficiency by the City Attorney.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its adoption.
