

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH MIND AND MELODY, INC FOR THE PROVISION OF SPECIAL NEEDS MUSIC PROGRAMMING FOR AN INITIAL TERM OF ONE (1) YEAR WITH A ONE (1) YEAR RENEWAL OPTION AT A RATE NOT TO EXCEED ONE HUNDRED AND SEVENTY FIVE DOLLARS AND 00/100 (\$175.00) PER CLASS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Mind and Melody was awarded an agreement with the City of Doral through RFP #2019-34 "Seniors and Special Needs Recreational Programs". This was approved during the November 19, 2019 Council Meeting (Res. 19-278). The agreement was signed on August 20, 2020 after our parks re-opened from the pandemic. The agreement was for three (3) years with two (2) one-year renewal options. After executing both renewal options their agreement is now set to expire on August 31, 2025; and

WHEREAS, Mind and Melody currently offers two programs at Doral Legacy Park. Their offerings include the Mind and Melody Music Program which is offered to the Special Needs Community once a week, and Genbeats which is a drum circle-style class offered to parents and siblings of individuals with Special Needs two Fridays every month. Both classes have been well received by participants and are considered therapeutic and beneficial for those participating; and

WHEREAS, These programs offered by Mind and Melody, Inc have been a benefit for the community for five years and it would be to the department and the City's benefit to continue these offerings by entering into a new agreement with Mind and Melody under the same terms and conditions with a one (1) year agreement with a one (1) year renewal option; and

WHEREAS, pursuant to Sec. 2-323(5) of the City Code, the City Manager's Office respectfully requests approval from the Mayor and City Councilmembers to authorize the City Manager to negotiate and enter into an agreement with Mind and Melody, Inc to provide Special Needs Music Programming under the same terms and conditions for a one (1) year agreement with a one (1) year renewal option in an amount not to exceed \$175 per class. Funding is available in Parks & Recreation account 001.90005.500340 (Contractual Services-Other).

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The Mayor and City Councilmembers, pursuant to Sec. 2-323(5) of the City Code, the City Manager's Office respectfully requests approval from the Mayor and City Councilmembers to authorize the City Manager to enter into an agreement with Mind and Melody, Inc to provide Special Needs Music Programming under the same terms and conditions for a one (1) year agreement with a one (1) year renewal option in an amount not to exceed \$175 per class.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

Section 4. Effective Date. This resolution shall take effect immediately upon adoption.
