## **RESOLUTION No. 25-**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING SETTLEMENT TERMS WITH YVETTE GOMEZ; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on or about January 9, 2020, former City of Doral (the "City) Police Officer Yvette Gomez filed a lawsuit against her employer, the City and (former) Mayor Juan Carlos Bermudez in the United States District Court Southern District of Florida Case No. 2020-000433-CA-01 (the "Litigation"); and

WHEREAS, (former) Mayor Juan Carlos Bermudez has been dismissed from the Litigation; and

WHEREAS, on or about March 18, 2022 Yvette Gomez filed her Third Amended Complaint in the United States District Court Southern District of Florida Case No. 2020-000433-CA-01 (the "Litigation"), the Third Amended Complaint contains three counts directed toward the Defendant City; and

WHEREAS, Yvette Gomez subsequently stipulated to the dismissal of Count III as contained in the Third Amended Complaint; and

WHEREAS, the Parties desire now to settle completely and for all time the matters raised in the Litigation, together with any and all other matters that might have been raised or that could have been raised in the Litigation; and

WHEREAS, in order to avoid the uncertainties, costs and expense of litigation, the Parties have agreed to settle and compromise this matter. A true and correct copy of the Settlement Agreement is attached hereto as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Incorporation of Recitals.</u> The aforementioned recitals are incorporated herein by reference.

Section 2. Authorization. The Mayor and City Council hereby authorize City Manager to accept the term's described in Exhibit "A," and authorize the City Manager and Attorney to negotiate a formal settlement agreement that will include terms in substantially the same form as Exhibit "A.", and authorize the City Manager and Attorney to negotiate a purchase and sale agreement in conformity with Exhibit "A" and any other necessary documents relating to the settlement as described in Exhibit "A."

<u>Section 3.</u> <u>Implementation.</u> The City Manager and City Attorney are authorized to take all necessary steps to implement this Resolution. The City Manager is authorized to expense budgeted funds in order to effectuate this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon adoption.
