

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE USE OF THE DORAL CULTURAL ARTS CENTER FACILITY AND THE USE OF THE CITY LOGO BY YOLA GUZ SI SE PUEDE CORP., A NON-PROFIT ORGANIZATION, FOR THE DORAL ARTS AND FLOWERS FESTIVAL 2026; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the “City”) recognizes the importance of supporting arts and culture in our community; and

WHEREAS, since its inception in 2018, the Doral Arts and Flowers Festival has served as a platform to showcase our communities artists, flower industry and our cultural diversity; and

WHEREAS, the City maintains deep roots in the floral industry, as a leading hub for flower and foliage imports into the United States and has been designated as the “City of Flowers”; and

WHEREAS, the Doral Arts and Flower Festival will run from April 9, 2026 through April 12, 2026, and is organized by Yola Guz Si Se Puede Corp., a Florida not-for-profit corporation, registered as a 501©3 with the Internal Revenue Service; and

WHEREAS, Yola Guz Si Se Puede Corp., desires to use the City’s logo to promote the Doral Arts and Flower Festival, and to host the event at the City’s Cultural Arts Center; and

WHEREAS, as per the City’s Charter Section 2-1.2 (f), use of the City’s logo by not-for-profits may only be used for events or programs occurring in the City and with approval by the Mayor and Council; and

WHEREAS, the Council finds it in the City's best interest to allow Yola Guz Si Se Puede Corp., to host the Doral Arts and Flower Festival at the City's Cultural Arts Center, and use of the City's logo for the events promotion.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by this reference as if fully set forth in this section.

Section 2. Approval of the City Logo and Use of the City's Cultural Arts Center. In accordance with Section 2-1.2 (f), Yola Guz Si Se Puede Corp., is hereby authorized to use the City logo for the promotion of their 2026 "Doral Arts and Flower Festival", subject to all of the requirements and limitations set forth in City Charter, and use of the City's Cultural Arts Center and all non-permit related associated fees and costs relating to the Cultural Arts Center's use through the dates of April 9-12, 2026.

Section 3. Effective Date. This Resolution shall take effect immediately upon its adoption.
