

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF INVITATION TO BID ITB#2025-22, "TABLES, TENTS AND CHAIRS," TO THE TOP-RANKED PROVIDERS; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH GLEN'S TENTS AND TABLE RENTAL SERVICE INC. AND SBS INVESTMENTS OF DADE COUNTY INC. FOR THE PROVISION OF RENTAL SERVICES FOR TENTS, TABLES AND CHAIRS FOR THE CITY'S RECREATIONAL PROGRAMS AND SPECIAL EVENTS, FOR A PERIOD OF THREE (3) YEARS WITH ONE (1) TWO (2) YEAR RENEWAL TERM, FOR A TOTAL OF FIVE (5) YEARS, IN AN AMOUNT NOT TO EXCEED APPROVED BUDGETED FUNDS PER FISCAL YEAR; PROVIDING AUTHORIZATION TO USE MIAMI DADE COUNTY RTQ-00880 IN ORDER TO EXPAND AND SUPPLEMENT THE VENDOR POOL FOR THESE SERVICES; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("City"), through its Parks and Recreation Department, in coordination with the Procurement and Asset Management Department, issued Invitation to Bid (ITB) No. 2025-22 on November 10, 2025, for the purpose of soliciting qualified and experienced vendors to provide rental services for tents, tables, and chairs in support of City programs and special events; and

WHEREAS, the ITB required the selected contractor to provide delivery, set-up, and break-down services for tents, tables, and chairs, as requested, in a timely and professional manner; and

WHEREAS, while the City will handle the permitting process, selected contractor is responsible for providing insurance, flame-retardant certificates, compliance with Fire Department regulations, and completing the permit application; and

WHEREAS, on December 11, 2025, the City received pricing proposals from five (5) vendors, of which four (4) vendors were deemed responsive after submitting pricing for

all required items; and

WHEREAS, following a comprehensive evaluation of the responsive proposal, the Procurement Department, with support from the Parks and Recreation, determined that Glen's Tent & Table Rental Service, Inc., submitted the lowest responsive bid, with SBS Investments of Dade County, Inc. identified as the second-lowest responsive bidder; and

WHEREAS, staff recommends award to both vendors. The primary vendor will be utilized when available, and the secondary vendor will be engaged if the primary vendor is unable to provide the requested services for a specific event or program; and

WHEREAS, the Procurement Department and the Parks and Recreation Department recommend awarding ITB No. 2025-22, "Tables, Tents and Chairs," to Glen's Tent & Table Rental Service, Inc and SBS Investments of Dade County Inc. for a period of three (3) years, with one (1) two (2) year renewal term, for a total contract term of five (5) years, in an amount not to exceed budgeted funds per fiscal year.

WHEREAS, the Procurement Department and the Parks and Recreation Department request authorization to use Miami Dade County RTQ-00880 in order to expand and supplement the vendor pool for these services, when needed.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The City Council hereby approves the award of Invitation to Bid No. 2025-22 to Glen's Tents and Table Rental Services Inc. and SBS Investments of Dade County Inc. and authorizes the City Manager to negotiate and

enter into an agreement with Glen's Tents and Table Rental Services Inc. and SBS Investments of Dade County Inc. for the provision of rental services for tents, tables and chairs for recreational programs and special events for a period of three (3) years, with one (1) two (2) year renewal term, for a total of five (5) years, in an amount not to exceed budgeted funds per fiscal year, subject to the terms and conditions acceptable to the City Manager and City Attorney. Additionally, The City Council authorizes the City Manager to use Miami Dade County RTQ-00880 in order to expand and supplement the vendor pool for these services, as needed.

Section 3. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 4. Effective Date. This resolution shall take effect immediately upon adoption.
