A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING SETTLEMENT TERMS WITH JUAN RAMIREZ DUQUE, FREDY DE JESUS AGUILAR BEDOYA AND VALERIA ANDREA AGUILAR; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on or about November 26, 2024, Plaintiffs filed this lawsuit in The United States District Court for the Southern District of Florida, Miami Division under Case No.: 1:24-cv-24662-RAR including claims of false arrest, malicious prosecution, and deprivation of civil rights (referred to herein as the "Lawsuit"); and

WHEREAS, the Parties desire now to settle completely and for all time the matters raised in the Lawsuit, together with any and all other matters that might have been raised or that could have been raised in the Lawsuit in this litigation and the City requires City Council approval of this Agreement; and

WHEREAS, in order to avoid the uncertainties, costs and expense of litigation, the Parties have agreed to settle and compromise this matter. A true and correct copy of the Settlement Agreement is attached hereto as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Incorporation of Recitals.</u> The aforementioned recitals are incorporated herein by reference.

Section 2. Authorization. The Mayor and City Council hereby authorize City Manager to accept the term's described in Exhibit "A," and authorize the City Manager and Attorney to negotiate a formal settlement agreement that will include terms in substantially the same form as Exhibit "A.", and authorize the City Manager and Attorney

to negotiate a purchase and sale agreement in conformity with Exhibit "A" and any other necessary documents relating to the settlement as described in Exhibit "A."

Section 3. Implementation. The City Manager and City Attorney are authorized to take all necessary steps to implement this Resolution. The City Manager is authorized to expense budgeted funds in order to effectuate this Resolution.

Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.
