

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT BY ANTUANET ALVAREZ ON BEHALF OF CODINA MANAGEMENT TO HOST THE “DOWNTOWN DORAL CHARTER UPPER SCHOOL NATIONAL SOCCER CHAMPIONS PARADE” AT 8551 NW 53 STREET, DORAL, FL 33166, ALONG NW 53 STREET BETWEEN NW 87 AVENUE AND NW 79 AVENUE, ON MARCH 16, 2026 FROM 10:00 A.M. TO 11:00 A.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Antuanet Alvarez (the “Applicant”) on behalf of Codina Management (the “Event Organizer”) seeks approval from the City of Doral to host the “Downtown Doral Charter Upper School National Soccer Champions Parade” special event at 8551 NW 53 Street, specifically along NW 53 Street between NW 87 Avenue and NW 79 Avenue; and

WHEREAS, the event is a celebratory parade honoring the Downtown Doral Charter Upper School’s Dolphins Soccer Team, who recently earned the distinction of National Champions for their division; and

WHEREAS, the City of Doral (the “City”) staff recommends that the Mayor and City Council approve the proposed “Downtown Doral Charter Upper School National Soccer Champions Parade” special event permit to be held on Monday, March 16, 2026, from 10:00 a.m. to 11:00 a.m.; and

WHEREAS, full street right-of-way closure begins on Monday, March 16, 2026, at 9:30 a.m. and ends at 11:30 a.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The special event permit for the “Downtown Doral Charter Upper School National Soccer Champions Parade” is hereby approved subject to the following conditions:

1. The Applicant shall comply with the comments made by the City of Doral Police Department for adequate security and pay all applicable fees no later than ten (10) days prior to the special event.
2. The Applicant shall provide the City of Doral an acceptable certificate of insurance naming the city as an additional insured ten (10) days prior to the event date.
3. The Applicant shall secure a maintenance of traffic (MOT) permit from the City of Doral Public Works Department and any other applicable permits as required by the City and/or Miami-Dade County Department of Transportation and Public Works prior to event start date.
4. All fees due must be paid within thirty (30) days upon special event approval. Total fees due for Downtown Doral Arts Festival special event are \$5,777.38 which represents \$4,412.38 for Police services and \$1,365.00 for Planning and Zoning and Technology fees.

Section 3. Effective Date. This Resolution shall become effective immediately upon its adoption.

Section 4. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council’s intent.
