

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDED INVITATION TO BID #2025-15 “EMERGENCY SANDBAG, SAND AND SUPPORT SERVICES” TO ESR LLC; THE LOWEST, MOST RESPONSIVE AND RESPONSIBLE BIDDER; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH ESR LLC FOR THE PROVISION OF EMERGENCY SANDBAG, SAND AND SUPPORT SERVICES ON AN AS-NEEDED BASIS FOR A PERIOD OF THREE (3) YEARS WITH AN OPTION TO RENEW FOR AN ADDITIONAL TWO (2) ONE-YEAR (1) PERIODS UNDER THE SAME TERMS, CONDITIONS, AND PRICES OF THE CONTRACT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, South Florida has a high exposure to hurricanes and tropical storms that can create a large economic impact; and

**WHEREAS**, the best way to mitigate these impacts is to have properly trained City staff and adequate resources that can respond to these emergencies in a timely manner; and

**WHEREAS**, in order to properly respond to emergency situations that cause damage to public and private infrastructure and create significant debris and flooding, such as a storm or a hurricane, the City of Doral has contracts with vendors that perform Emergency Debris Removal Services, and Emergency Debris Monitoring Services; and

**WHEREAS**, another important component of a properly established response plan is the capability of providing sand, bags, and prepared sandbags on an as-needed basis during emergencies; and

**WHEREAS**, FEMA requires these types of services to be procured through publicly advertised contracts in order to ensure compliance and reimbursement.

**WHEREAS**, on June 12, 2025, the City of Doral issued Invitation to Bid #2025-15 “Emergency Sandbag, Sand and Support Services” (the ITB) to competitively advertise the sandbag services; and

**WHEREAS**, the City received one (1) submittal in response to the ITB which was opened on July 15, 2025; and

**WHEREAS**, upon review of the bids submitted, City Staff respectfully requests that the City Council authorize the City Manager to enter into an agreement with ESR, LLC who was deemed the lowest most responsive and responsible bidder for the provision of emergency sandbag, sand and support services for a three (3) year period with the option to renew for an additional two (2) one-year (1) periods under the same terms, conditions, and contract prices; and

**WHEREAS**, it should be noted that all these services are only utilized during emergencies, on an as needed basis; and

**WHEREAS**, funding for this request is allocated in the City’s emergency fund.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** The contract between the City and ESR, LLC for Emergency Sandbag, Sand and Support Services for a three (3) year period with the option to renew for an additional two (2) one-year (1) periods under the same terms, conditions, and costs of the contract, in an amount not to exceed annual budgeted funds, is hereby approved

**Section 3. Authorization.** The City Manager is authorized to execute the Agreement and expend budgeted funds on behalf of the City.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
