

**RESOLUTION No. 26-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE CO-DESIGNATION OF NW 92 AVENUE FROM NW 33 STREET TO NW 25 STREET AS “MARIA CORINA MACHADO WAY”; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”), Code, Chapter 38, Article III, provides for the exclusive method for the co-designation of City streets; and

**WHEREAS**, Maria Corina-Machado, is a Venezuelan activist who has championed democratic principles by advocating for free and open elections in Venezuela through non-violence; and

**WHEREAS**, in 2025, Maria Corina-Machado’s efforts paved the way for her receipt of the Nobel Peace Prize; and

**WHEREAS**, the City is home to the largest diaspora of Venezuelans living abroad; and

**WHEREAS**, given the events of January 3, 2026, it is an appropriate time to honor Maria Corina-Machado’s works; and

**WHEREAS**, this item is sponsored by Councilman Rafael Pineyro; and

**WHEREAS**, the City’s Public Works Department (“PWD”) has evaluated the application and verified that all of the City’s Code requirements has been satisfied; and

**WHEREAS**, the PWD submits its approval of the co-designation of N.W. 92<sup>nd</sup> Avenue, between N.W. 33<sup>rd</sup> Street and N.W. 25<sup>th</sup> Street as Maria Corina Machado Way; and

**WHEREAS**, the PWD recommends waiving the \$1,000 application fee.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Incorporation of Recitals.** The aforementioned recitals are incorporated herein by reference.

**Section 2. Approval.** The application for the co-designation of N.W. 92<sup>nd</sup> Avenue, between N.W. 33<sup>rd</sup> Street and N.W. 25<sup>th</sup> Street, as "Maria Corina Machado Way," is hereby approved.

**Section 3. Implementation.** The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon adoption.

The Prime Sponsor of the foregoing resolution is Councilman Rafael Pineyro.
