



## **CITY OF DORAL COUNCIL MEETING MEMORANDUM MAYOR AND COUNCIL**

### **ITEM TITLE:**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, EXPRESSING SUPPORT FOR THE FLORIDA STATE DEPARTMENT OF GOVERNMENTAL EFFICIENCY (DOGE) TASK FORCE, AS INITIATED BY GOVERNOR RON DESANTIS, FOLLOWING THE FEDERAL GOVERNMENT'S DEPARTMENT OF GOVERNMENT EFFICIENCY MODEL; AUTHORIZING THE CITY OF DORAL TO PARTICIPATE IN A VOLUNTARY FINANCIAL REVIEW IN COLLABORATION WITH FLORIDA DOGE; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

### **BRIEF HISTORY:**

The Department of Government Efficiency (DOGE) originated as a federal initiative under President Donald J. Trump's current administration, focusing on eliminating wasteful government spending, promoting financial transparency, and ensuring efficiency across federal agencies. Governor Ron DeSantis established the Florida DOGE Task Force in February 2025, applying this model to improve fiscal accountability in state and local governments.

In March 25, 2025, the City of Hialeah approved Resolution No. 2025-088, supporting participation in the Florida DOGE initiative. This approval marks a significant step, as Hialeah is one of Florida's largest municipalities, setting an important precedent for other cities considering voluntary collaboration with the state to enhance fiscal oversight and operational efficiency. The City of Doral seeks to join this growing statewide effort, demonstrating leadership in responsible governance. This participation is voluntary, imposes no financial obligation, and will help ensure responsible use of taxpayer funds.
