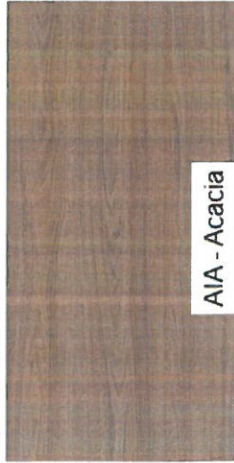


Key Plan
