

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE PROJECT EXTENSION FOR STATE FISCAL YEAR 2025–2026 VIA THE VOLUNTARY COOPERATION MUTUAL AID AGREEMENT (STATE ASSISTANCE FOR FENTANYL ERADICATION) WITH THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT; AIMED AT COMBATTING THE OPIOID CRISIS BY DISRUPTING THE SUPPLY CHAIN OF FENTANYL, A POTENT AND OFTEN FATAL SYNTHETIC OPIOID; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the State Assistance for Fentanyl Eradication (S.A.F.E) initiative was created by the State of Florida Department of Law Enforcement (“FDLE”) to maximize the combined resources and expertise of law enforcement agencies throughout the State of Florida in order to combat the fentanyl epidemic in Florida; and

WHEREAS, State of Florida legislature has extended the S.A.F.E. initiative funding through Fiscal Year 2025–2026. The S.A.F.E. initiative will maintain its role in providing resources and assistance to law enforcement agencies, strengthening their efforts to identify, dismantle, and prosecute individuals and organizations involved in the illegal distribution and trafficking of fentanyl; and

WHEREAS, the City of Doral (the “City”) police department has participated in the S.A.F.E. initiative through the execution of a Voluntary Cooperation Mutual Aid Agreement with the State of Florida’s Department of Law Enforcement; and

WHEREAS, Staff has recommended that the City Council approve the City’s Police Department continuation of its participation with the S.A.F.E. initiative for State Fiscal Year 2025-2026, and the execution of the Voluntary Cooperation Mutual Aid Agreement with the Florida Department of Law Enforcement.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The project extension for State Fiscal Year 2025-2026 under the Voluntary Cooperation Mutual Aid Agreement (S.A.F.E. Initiative) between Florida Department of Law Enforcement and City of Doral, attached hereto as Exhibit “A”, which is incorporated herein and made a part hereof by this reference, is hereby approved. The City Manager is hereby authorized to execute the Voluntary Cooperation Mutual Aid Agreement on behalf of the City subject to approval as to form and legal sufficiency by the City Attorney.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 4. Effective Date. This Resolution shall become effective immediately upon its adoption.
