

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING A MUNICIPAL SPONSORSHIP TO THE BREASTIES SUPPORT CENTER FOR WOMEN CORP IN THE AMOUNT OF ONE THOUSAND DOLLARS AND 00/100 (\$1,000.00), PURSUANT TO SECTION 2-79 OF THE CITY'S CODE OF ORDINANCES; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-79 of the Code of Ordinances for the City of Doral ("City") governs municipal sponsorships and provides that each councilmember is allotted \$5,000.00 per fiscal year (contingent upon annual city budget approval) to sponsor eligible applicants whose events, services, and programs support the City's vision, mission, and values as set forth in the City's adopted strategic plan and provide a community benefit; and

WHEREAS, the purpose of this section is to establish procedures for all municipal sponsorships, including the disbursement of discretionary funds approved by city councilmembers to sponsor programs, services, events, and charitable and civic organizations that serve a municipal purpose; and

WHEREAS, in a continued commitment to supporting non-profit organizations that embody our core values and significantly contribute to the well-being of our community, Councilwoman Nicole Reinoso proposes sponsorship for The Breasties Support Center for Women Corp; and

WHEREAS, The Breasties Support Center for Women Corp is a nonprofit organization recognized as tax-exempt under Section 501(c)(3) of the Internal Revenue Code, effective September 8, 2025, and classified as a public charity, with contributions deemed tax-deductible; and

WHEREAS, The Breasties Support Center for Women Corp is dedicated to supporting women through education, resources, and community-based initiatives focused on breast health awareness, early detection, emotional support, and access to care, thereby improving health outcomes and empowering women and families within the community; and

WHEREAS, the organization operates within South Florida, including Miami-Dade County, and provides programs and services that promote public health, community wellness, and access to critical support systems, aligning with the City of Doral's commitment to enhancing quality of life, supporting vulnerable populations, and fostering a healthy and informed community; and

WHEREAS, in accordance with Section 2-79 of Municipal Sponsorships, Councilwoman Nicole Reinoso proposes a municipal sponsorship in the amount of ONE THOUSAND DOLLARS AND 00/100 (\$1,000.00) to support The Breasties Support Center for Women Corp and its health-focused initiatives and programs; and

WHEREAS, the City Council finds that the proposed municipal sponsorship complies with Section 2-79 of the City's Code of Ordinances and that the sponsorship serves a valid municipal purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. . The above recitals are true and correct and incorporated herein.

Section 2. Approval & Authorization. The Mayor and City Council hereby approve the municipal sponsorship proposed by Councilwoman Nicole Reinoso to The

Breasties Support Center for Women Corp. The City Manager is hereby authorized to expend the budgeted funds.

Section 3. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

The Prime Sponsor of the foregoing resolution is Councilwoman Nicole Reinoso.
