

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE PRIOR PURCHASE OF LICENSE PLATE READERS EQUIPMENT AND INSTALLATION FROM MILLENIUM PRODUCTS INC DUE TO AN UNFORESEEN EMERGENCY; AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS ON BEHALF OF THE CITY IN FURTHERANCE THEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (“City”) Information Technology Department requests authorization for the prior purchase of License Plate Readers (LPR) equipment and installation, from Millenium Products Inc., a public sector procurement partner; and

WHEREAS, the LPR manufacturer has informed the City that some models are now at the end of life due to a newly identified security vulnerability; and

WHEREAS, to ensure operational security, continuous system coverage, and support for public safety efforts, an urgent upgrade and replacement of these units is necessary. Delaying this purchase could expose the City to security threats and potential service interruptions; and

WHEREAS, we aim to continue working with the same contractor previously used for purchasing, deploying, and configuring LPR equipment. This vendor is already familiar with our current systems and infrastructure, enabling them to perform a quick and smooth replacement; and

WHEREAS, the vendor’s ongoing involvement will reduce downtime, ensure compatibility with existing components, and maintain continuity of public safety operations. Other vendors would not be able to provide the equipment or complete

the configuration within the urgent timeframe; and

WHEREAS, Section 119.0725 (b) of the Florida Statutes creates a public records exemption related to cybersecurity. Specifically, the statute makes confidential and exempt from public record requirements any information related to critical infrastructure. Additionally, any portion of a meeting that might reveal such information is also exempt from public meeting requirements. See Section 119.0725(3), Florida Statutes; and

WHEREAS, pursuant to Section 2-322 of the City's Code of Ordinances, the City is authorized to purchase supplies, materials, equipment, and contractual services which are the subject of contracts through cooperative purchasing ventures, where the best interest of the City would be served thereby; and

WHEREAS, the City Manager respectfully requests that City Council authorize the use of GSA Contract GS-07F-0031W for the prior purchase of the LPR equipment and installation, as required by the city, from Millenium Products in an amount not to exceed \$233,941.38.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference

Section 2. Approval. The purchase of an access control system and equipment from VCS Tech Systems, LLC.

Section 3. Authorization. The City Council hereby authorizes the use of the GSA Contract GS-07F-0031W for the prior purchase of the LPR equipment and installation,

as required by the city, from Millenium Products in an amount not to exceed \$233,941.38, which was funded from the IT Capital Account, 001.22005.500640.

Section 4. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.
