Re: School Zone Speed Detection IRFP

It is my pleasure to submit this proposal on behalf of SaferSpeeds, LLC ("SaferSpeeds") to the City of Doral's ("City") Informal Request for Proposal ("IRFP") for the School Zone Speed Detection.

SaferSpeeds, a wholly owned entity of Vetted Holdings, LLC ("Vetted Holdings"), has direct access to software engineers and hardware manufacturers through our wholly owned affiliated companies, FINDER Software Solutions, LLC ("FINDER") and Vetted Security Solutions, LLC ("Vetted"). These resources give us the unique ability to adapt quickly to changing regulations, needs, and circumstances.

SaferSpeeds proposes to furnish the City with a school zone speed detection program, encompassing speed detection systems in accordance with Florida Statute. This program is intended to cover the requested 15 school zones, consisting of approximately 29 roadway segments, and any additional school zones as designated by the City.

As set forth in the IRFP, SaferSpeeds will be responsible for all costs related to installation, maintenance, operation, calibration, regulatory compliance, and administration of the speed detection system. We also provide the TechAlert system to remotely monitor the health and status of the speed detection system to minimize or eliminate system downtime. As compensation, SaferSpeeds proposes a revenue-sharing arrangement where \$42 of the \$60 statutory allocation goes to the City and \$18 to SaferSpeeds for each paid notice and citation.

The Vetted Holdings companies have a long history of supporting law enforcement agencies in the State of Florida, including the Doral Police Department, and we very much appreciate the opportunity to offer our services in support of the City's mission to keep its children safe.

Traffic Study

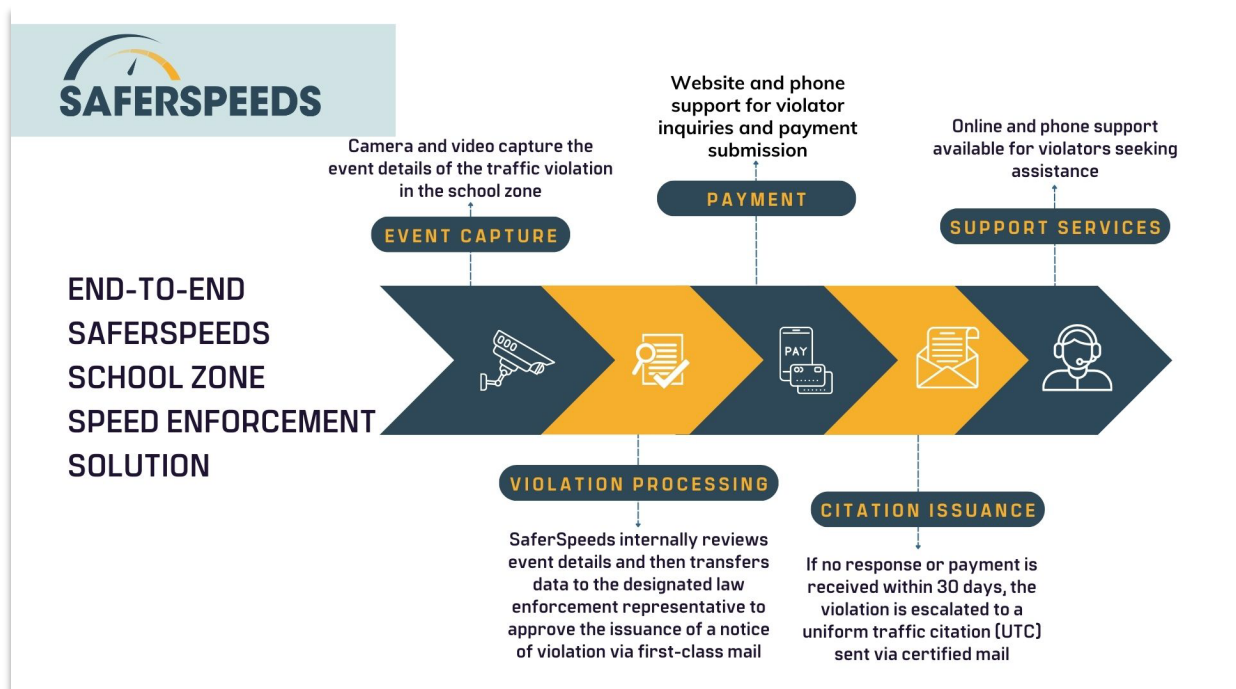
According to Florida Statute, a county or municipality must assess that each targeted school zone for speed detection system installation presents a "heightened safety risk that warrants additional enforcement measures." SaferSpeeds offers a thorough school zone traffic study that can aid in identifying eligible zones as outlined by the Florida Statute. Our traffic study yields crucial data, including vehicle counts and speeding rates during both designated school zone and non-school zone hours, in accordance with the stipulations of the Florida Statute.

Municipal Ordinance

According to the Florida Statute, counties or municipalities "must enact an ordinance to authorize the placement or installment of a speed detection system. " This process involves a public hearing that "must consider traffic data or other evidence..." SaferSpeeds, in collaboration with your legal counsel, can provide assistance in drafting the ordinance for your city.

End-to-End Solution

SaferSpeeds offers comprehensive services encompassing the provision, installation per Florida Department of Transportation (FDOT) specifications, and maintenance of all signage and equipment necessary for a fully automated speed enforcement system. Additionally, we provide continuous service and support throughout the entire violation lifecycle.




Violations

The violation processing commences at the edge, employing radar capable of covering up to six lanes at ranges reaching up to 574 ft. The correlation of vehicle license plate and radar data is uploaded to our secure server hosted on AWS GovCloud, ensuring full CJIS compliance.

Prior to initiating the school zone speed enforcement program, SaferSpeeds will require a set of written specifications and guidelines from the City. This allows SaferSpeeds to sift through the data, distinguishing between usable and unusable information, before forwarding it to the Traffic Infraction Enforcement Officer for a charging determination for the issuance or non-issuance of a Notice of Violation. This internal review process safeguards the validity of the data and contributes to the efficiency of law enforcement administrative procedures.

Subsequently, a traffic enforcement officer conducts a final verification of the violation. Upon officer approval of the violation, the SaferSpeeds system issues a notice of violation, which is mailed to the vehicle's registered owner. If no response is received within 30 days, the agency upgrades the violation notice to a Uniform Traffic Citation.

Citations

A digital block of UTC numbers, provided by FDLE using the agency ORI number, is incorporated into our management process, which is designed to be turnkey. SaferSpeeds can electronically submit the issued UTCs to the designated court clerk. Once officer approval is granted, SaferSpeeds will initiate the notification process.

Data

SaferSpeeds follows the requirements for retaining and destroying data obtained from speed detection systems.

Reporting

SaferSpeeds' system facilitates the generation of annual reports, including a yearly summary report as mandated by the Department of Highway Safety and Motor Vehicles ("DHSMV"), along with any additional reports stipulated by the pertinent Florida Statutes.

Training

SaferSpeeds will provide the essential training to designated City personnel, with a primary focus on the nuances of citation verification. The training aims to underscore the critical significance of precision and dependability in data. Participants will acquire the ability to discern and evaluate the pertinence and timeliness of information, while adhering to established legal citation standards.

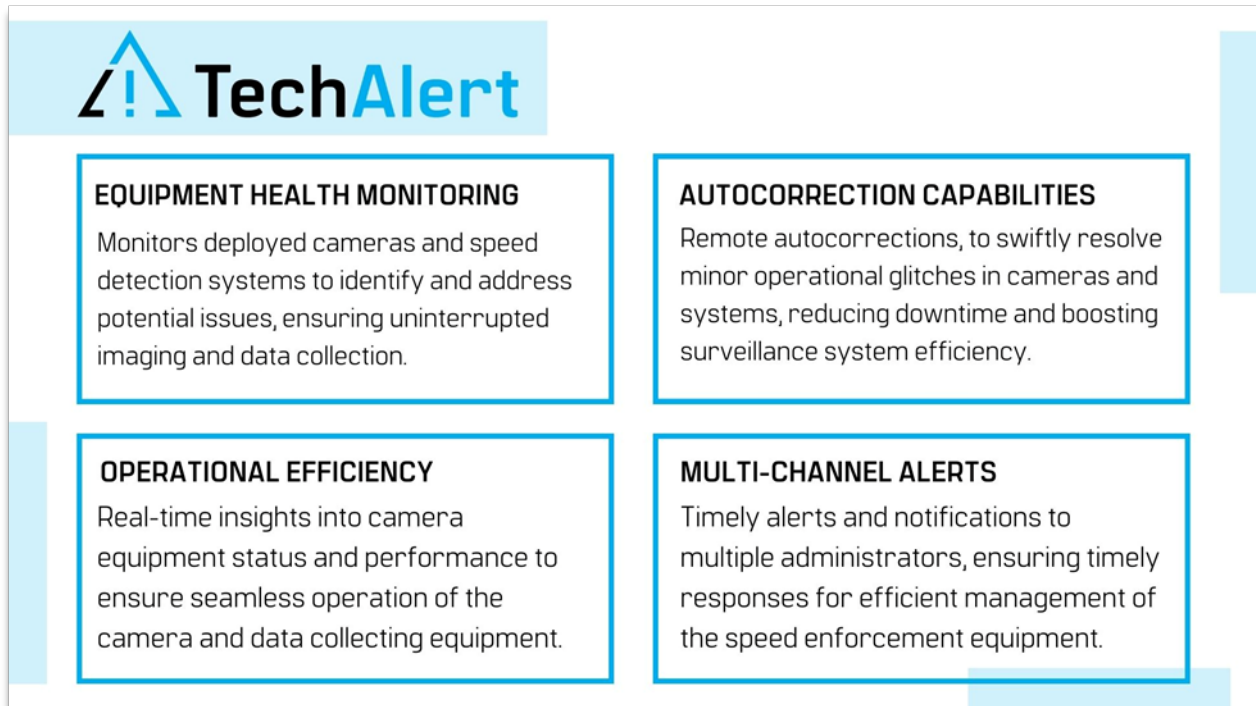
Additionally, the training program will encompass the tools and methodologies requisite for real-time monitoring of system health. This will entail comprehension of system metrics, identification of potential issues, and proficiency in responding effectively to uphold the system's peak performance. Designated team members from the City will be equipped with the necessary skills to ensure optimal system functionality and uphold the highest standards in citation approval.

Field Maintenance and Repair

SaferSpeeds's solution encompasses both the maintenance and repair of systems aimed at sustaining the utmost quality and operational efficiency. With highly proficient technicians situated within 50 miles of the City, SaferSpeeds is well-positioned to deliver swift and timely maintenance and repair services for the speed detection systems deployed across the City's school zones.

Enhanced Feature of a SaferSpeeds Solution

SaferSpeeds will reconcile the collections and issue an invoice to the City monthly.

SaferSpeeds will align the appeals process for a notice of violation and uniform traffic citation to your existing structured process utilized by your county or municipality for civil violation fines.

SaferSpeeds provides the allowable defense affidavit for persons who receive a notice of violation or uniform traffic citation and procedures for hearings regarding violations.

SaferSpeeds will invoice the City of Doral \$18 per paid infraction.

Our proposal shall remain in effect for one hundred and twenty (120) days from the submitted date.

Should the City terminate the contract with SaferSpeeds for SaferSpeeds' failure to meet its contractual terms the City would not be subject to an early termination fee. However, should the City terminate the contract for a reason other than because of SaferSpeeds failure to meet its contractual terms, SaferSpeeds would be entitled to recover for the cost of its equipment, equipment installation and equipment removal based on the following schedule.

Please be advised that this Informal Request for Proposals is only available to a restricted pool of Proposers pursuant to City of Doral Council Resolution for Bid Waiver.

On January 10, 2024, the City of Doral ("City") Mayor and Council directed the City Manager and staff to (i) conduct an informal competitive process seeking proposals from the vendors offering speed detection services that have already met with City staff as of January 10, 2024, and (ii) to bring an item to Council in March or April to waive formal competitive bidding procedures and award to a vendor pursuant to Section 2-321 of the City's Code of Ordinances.

Accordingly, the City is seeking proposals through this informal selection process ("Solicitation" or "IRFP") from identified vendors to provide the City of Doral with a school zone speed detection system. The selected firm will also be responsible for providing the full range of associated support services such as: violation validation, customer service, correspondence processing, noticing, violations processing, interfacing with other public agencies, as needed, payment processing, collections, reporting, field maintenance and repair services, adjudication support and training, and any other services required by the City in connection with the school zone speed detection system. The equipment and monitoring will be provided at no cost to the City, with revenue sharing of any collections.

Proposers must be qualified to, and responsible for, installing all equipment and monitoring the school zone speed detection and camera system for violations in accordance with Section 316.008(9), Florida Statutes, and applicable Florida Department of Transportation guidelines.

The City is currently in the process of conducting a study to collect vehicular traffic volumes and speed counts within 15 schools with approximately 29 roadway segments that have existing speed zones. The City will review the findings of such study, and as applicable, will enact an ordinance in order to authorize the placement or installation of a speed detection system on any roadways that the City determines presents a heightened safety risk that warrants additional enforcement measures.

Award of this Solicitation will be pursuant to City Mayor and Council review and approval and will be based upon Proposer's qualifications and experience, quality of services, fees and financials, and overall approach. The City reserves the right to require Proposers to present to City staff and/or City Council prior to recommendation and/or contract execution. The City anticipates awarding a contract for an initial term of five (5) years but reserves the right to award a contract term for a period of time as may be necessary or advantageous to the City in its sole discretion. The City may negotiate modifications to proposals after selection that it deems acceptable and in its best interest.

This Solicitation and addenda or notices in connection therewith will be issued via email from the Department of Procurement and Asset Management. To receive notifications of addenda or notices issued in connection with this IRFP, interested parties must confirm receipt and identify the appropriate contact person.

This Solicitation is subject to the "Cone of Silence" as defined in Section 2-11.1(t) of the Miami-Dade County Code of Ordinances. Accordingly, all questions and/or comments regarding this Solicitation must be made in writing and be directed to Procurement at the following email at procurement@cityofdoral.com. 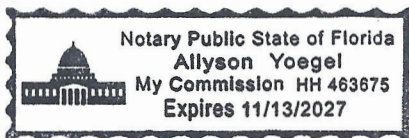

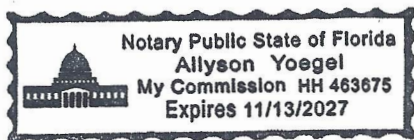
